2. And whereas it has been agreed that the above appointed candidate by name

enter into a service bond for the above-mentioned sum with such conditions as hereunder written

3. Now the conditions of the above written bond are such that (i) if for any reason other than  
death or disability or other causes acceptable to the TSTRANSCO, the first of the said three leaves  
the Corporation during the period of training of one year, he/she shall refund to the TSTRANSCO the  
amount of emoluments received by him/her plus Rs.50,000/- (Rupees fifty thousand only) by way of  
liquidated damages within one month of demand (ii) The above party by name (1)  
\_\_\_\_\_ shall serve the TSTRANSCO for a period of five years after  
successful completion of training period of one year and shall during such period of service abide by  
all the Rules and Regulations as will be applicable to him/her. If for any reason other than death or  
disability or other causes acceptable to the corporation, the appointee fails to serve the TSTRANSCO  
for atleast five years he/she shall pay the TSTRANSCO by way of liquidated damages a sum of  
Rs.1,00,000/- (Rupees one lakh only) within one month of demand. Unless the said appointee (1)  
\_\_\_\_\_ is prevented by accident or ill-health certified by a competent medical  
authority for serving the TSTRANSCO at least for a period of five years, or the above appointee  
(1) \_\_\_\_\_ is removed from  
service for any misconduct before the expiry of the said period of five years, or shall for reasons  
acceptable to the appointing authority that he/she is unable to comply with all or any of the terms  
and conditions of employment above named. The above appointee (1)  
\_\_\_\_\_ and or (2) \_\_\_\_\_ (1<sup>st</sup>  
Surety) and or (3) \_\_\_\_\_ (2<sup>nd</sup> Surety) shall at all  
times within thirty days of the receipt of notice in writing from the appointing authority pay all sums  
of money that may become payable or refundable to the TSTRANSCO by the above by the said

4. Provided that any forgiveness or forbearance on the part of the TSTRANSCO towards the above  
appointee in respect of his/her failure or neglect to perform such services and duties or any  
forbearance or indulgence shown by the said TSTRANSCO whether as to payment, time for  
performance or otherwise shall not in any way release or exonerate the sureties or either of them,  
their or either of their executors or administrators in respect of their or his/her liability under the  
above written bond.
