In the reference (1) cited above, TSTRANSCO issued orders making institutional arrangements for power trading by DISCOMs in Telangana State. The Orders stipulated that salaries and all other expenditure of any nature, of employees deputed to TSPCC from TSTRANSCO will be initially processed and paid by TSTRANSCO. The orders also provided for reimbursement of such payments by TSPCC/TSDISCOMs based on the claim made by FA&CCA/Accounts/TSTRANSCO.
