Sub: Estt. – Sub-Committee on behalf of TS Power Utilities – Bifurcation of State Cadre Employees between TS and AP Power Utilities - Provisional Allocation List of “Allocable State Cadre Employees” working in TS Power Utilities and allocated to TS & AP Power Utilities – Published.

In the reference 1st cited, the Hon’ble Division Bench of High Court of Judicature at Hyderabad, was pleased to observe that “.....during the hearing, a suggestion has fallen from the Bench that unless options are called for, the number of employees opting for the State of Andhra Pradesh cannot be ascertained and that on receiving the options, if the employees who opt for Andhra Pradesh are in reasonable number to enable the State of Andhra Pradesh to accommodate them in the existing posts or by creating a few supernumerary posts, the issue may be solved. The Learned Advocate General for the State of Telangana has graciously agreed for calling for options by the Telangana TRANSCO, GENCO and DISCOMS from the all the employees who are identified as belonging to the State of Andhra Pradesh and initiate further negotiations after calling for such options, without prejudice to their stand in the Writ Petitions. He submitted that such options can be submitted within two weeks from today and thereafter further negotiations will be held.....”. Accordingly, options were called for from 1157 employees belonging to AP Power utilities working on “Order to Serve” basis in TS Power utilities. The details of the (i) 1157 employees working in TS

Power Utility-wise identified as belonging to the State of Andhra Pradesh, (ii) Opted to TS Power Utilities, (iii) Opted to AP Power Utilities; and (iv) Option not exercised, are as follows:

2. In the reference 2nd cited, the Hon'ble Supreme Court was pleased to appoint Hon'ble Justice D.M. Dharmadhikari, former Judge of Hon'ble Supreme Court of India as "One Man Committee" to determine the modalities for distributing the personnel i.e. the aforesaid 1157 employees and the Hon'ble Judge can take assistance of the representatives from both the States in this matter. During the course of Committee meetings held on 17-04-2019, the One Man Committee has appointed a Sub-Committee consisting One Member representing each of T.S and A.P. Power Utilities.

3. In the reference 3rd cited, the One Man Committee has framed Final Modalities for allocation of the State Cadre Employees between the TS & AP Power Utilities. While framing the modalities the One Man Committee has given certain working modalities for Sub-Committee which inter-alia stipulates (i) members of the Sub-committee will first prepare separate lists category-wise of allocable employees. Allocable employees will be considered Seniority-wise depending upon their "Home District" and "Option"; (ii) the Sub-Committee may proceed as far as possible, attempt be made to allocate the employees in the State in which the "Home District" is included; (iii) the Sub-Committee will separately consider 1157 employees; (iv) attempt will be made on the basis of their "Home District" to accommodate them in Telangana or Andhra Pradesh as per their "Option"; and (v) 229 employees who were allowed to join from the State of A.P to Telangana would be considered separately to accommodate them in Telangana as far as possible.

4. As per the final modalities, inter-alia stipulates that (i) all identified allocable employees in Power Utilities of United A.P including 1157 employees relieved by T.S Power Utilities plus 229 employees allowed to join in T.S Power Utilities from A.P Power Utilities will be considered for final allocation to the new States of Telangana and A.P on "as is where is" basis on the appointed

day (i.e) 02-06-2014; (ii) the allocable employees will have liberty to give options in the prescribed form annexed to the final modalities. However, the employees who have already exercised options will not be allowed again to submit options for a different place or location in any of the two States. The opportunity of submitting options in the prescribed form would be available only to such employees who have not submitted their options earlier; (iii) The allocable employees would, as far as possible after consideration of their options be adjusted in the State in which their "Home District" falls as per the information contained in their Service Records and obtained from them through the information available and provided by them in their written representations; and (iv) all the employees who have retired/died after the appointed day (i.e.) 02-06-2014 and the Pensioners/Family Pensioners shall also be allotted as per the formulated guidelines.

5. In the reference 4th cited, the One Man Committee on 30-08-2019, directed the Sub-Committee of TS Power Utilities to call for the Options from all the State Cadre Employees working in TS Power Utilities including 42 employees who have not exercised the Options earlier as per the interim Orders dtd.03-11-2017 in WP.No.16330/2015 & Batch of the Hon'ble Division Bench for the state of Telangana and for the State of Andhra Pradesh.

6. As directed by the One Man Committee in the reference 3rd and 4th cited, the T.S power utilities vide reference 5th cited have called for Options. The details of options exercised by the State Cadre Employees who are on rolls as on 02-06-2014 in the rank of AE and equivalent cadres and above, and all employees working at Head Quarters of TSGENCO, TSTRANSCO, TSSPDCL & TSNPDCL, including 42 employees who have not exercised option earlier in terms of the order dated.03-11-2017 of the Division Bench of Hon'ble High Court are as follows:

7. As per the proceedings mentioned in the references 3rd and 4th cited, 4868 employees were identified as State Cadre allocable Employees and working in T.S power utilities on "Order to Serve" basis, including 1157 employees. Out of which, 1157 employees belonging to A.P Power Utilities working in T.S Power Utilities on "Order to Serve" basis as mentioned in Para-6 above, were relieved from T.S power utilities. Out of 1157 employees, 502 employees have opted to T.S Power Utilities and 613 employees have opted to A.P Power Utilities. As per the final modalities framed by the One Man committee, the 613 employees whose names are mentioned in the Annexure-1 appended to this order are provisionally allocated to "A.P Power Utilities" as they are satisfying all the conditions of the modalities. The 502 employees belonging to AP Power Utilities working on "Order to serve" basis in T.S power utilities and opted to T.S Power Utilities are not meeting the final guidelines framed by the One Man Committee, and even on verification of their Service Records all these 502 employees were originally recruited in the geographical area now falling within the jurisdiction of residual State of Andhra Pradesh and their local status is also falling within the jurisdiction of residual State of A.P as defined under Presidential Order. Therefore, all these 502 employees whose names are mentioned in the Annexure-2 appended to this order are provisionally allocated to "A.P Power Utilities". The remaining 42 employees belonging to A.P Power Utilities as per the Service Record / local status, working in T.S Power Utilities on "Order-to-Serve" basis, whose names are indicated in the Annexure-3 are also provisionally allocated to A.P Power Utilities since the A.P Power Utilities being the "Principal Employer" and their local status / Home District including their initial recruitment is falling within the jurisdiction of residual State of A.P.

8. As stated supra, 4868 employees were identified as allocable State Cadre Employees, out of which 1157 employees belonging to A.P power utilities working in T.S power utilities on "order to serve" basis were relieved from T.S power utilities. Thus, the net State Cadre allocable employees working on "order to serve" basis in T.S power utilities are 3711. Therefore, these 3711 State Cadre employees are now to be allocated between T.S and A.P power utilities. Out of which, 3637 employees as detailed below have now opted to TS Power Utilities whose names are shown in the Annexure-4 are provisionally allocated to TS Power Utilities. 14 employees working on "order to serve" basis in T.S power utilities whose names are indicated in Annexure-5 have now opted to A.P power utilities and they are provisionally allocated to A.P power utilities as detailed below. 60 employees working on "Order to serve" basis in T.S power utilities who have not exercised options and whose names are indicated in Annexure-6 are also provisionally allocated to A.P power

utilities since the A.P power utilities are "Principal Employers" to these employees. Out of 784 employees opted to TSTRANSCO, 5 employees whose names are indicated in Annexure-7 are not meeting the guidelines framed by the One Man Committee and therefore their option to TSTRANSCO is rejected and they are allocated to APTRANSCO.

9. The 229 employees who have self-relieved from A.P power utilities and joined in T.S power utilities whose names are indicated in the Annexure-8 are provisionally allocated to T.S power utilities.

10. As per the references 6th to 8th cited, the total number of employees belonging to and working in A.P Power Utilities and now opting to T.S Power Utilities are as follows:

Note : Out of 50 employees opting from APSPDCL to TSSPDCL, 5 employees have already self-relieved from APSPDCL and joined in TSSPDCL, One employee named K.Venkata Naidu, AAE, is repeated, the cases of 4 employees will be examined separately and the remaining 40 employees are not meeting the guidelines for allocation to TSSPDCL. Therefore their option to TSSPDCL is rejected and they remained allocated to APSPDCL.

11. Out of the 256 employees belonging to and working in A.P Power Utilities, the 235 employees whose names are indicated in Annexure-9 are not satisfying the modalities fixed by

One Man Committee. Therefore, their Option to T.S Power Utilities is rejected on the ground that they are not meeting the guidelines framed by One Man Committee. The cases of remaining 15 employees whose names are indicated in Annexure-10, who are satisfying prima-facie guidelines of One Man Committee and opted to T.S Power Utilities will be examined separately on case-to-case basis and they cannot claim any right whatsoever towards their allocation to T.S power utilities.
