TERMS AND CONDITIONS Section-A (General) 1. GENERAL INSTRUCTIONS TO THE BIDDERS

- 1.1 **General:** The TGTRANSCO invites bids for the works mentioned in the NIT and Project Data sheet for which dates and time specified in the NIT and will be opened by either bid inviting authority or his nominee at his office on the date and time mentioned in the NIT. The details of Bid inviting authority are mentioned in the Project Data Sheet.
- 1.2 The Bids should be in the prescribed form invited as specified in NIT as per specification.
- 1.3 The dates stipulated in the NIT are firm and under any circumstances they will not be relaxed unless officially extended by TGTRANSCO.
- 1.4 The successful Bidder is expected to complete the work within the time period specified in the Schedule B.
- 1.5 TGTRANSCO reserves the right to cancel/extend/alter the bid & bid conditions at any time. In the process, if the tender process / works are stalled due to legal intervention or due to natural calamities, no compensation will be paid.

2. Bidders / Firms eligible to Bid:

- i) Are not blacklisted or debarred or suspended by the Government /any power utility for whatever the reason, prohibiting them not to continue in the contracting business.
- ii) The bidder should have valid PAN card.
- iii) The bidder should have valid GST registration
- iv) The bidder should have valid firm registration & partnership deed in case of firm
- v) The bidder should have Similar work experience in TGTRANSCO.

The bidder shall meet the qualification requirements mentioned notified item. The bidder should furnish documentary evidence in support of the qualifying requirements stipulated as above certified by Order Placing authority of the concerned Power utility/Government Organizations.

- 3. Even though the Bidders meet the above qualification requirements, they are liable to be disqualified / debarred / suspended / blacklisted if they have
 - a) Furnished false / fabricated particulars in the forms, statements and / annexures submitted in proof of the qualification requirements and/or
 - b) Not turning up for taking up the work within 15days from the date of LOA or intimation of taking of handing over of site and/or
 - c) Not turned up for entering into agreement, when called upon within the time specified in the letter of acceptance.
 - d) Record of poor progress such as abandoning the work, not properly completing the contract, inordinate delays in completion, litigation history or financial failures etc., and
 - e) A history of criminal record in which the Bidder is involved if any.
 - f) History of litigation with Government/TGTRANSCO during the last 5 years in which the Bidder is involved.

4. SUBMISSION OF BIDS:

- 4.1 The bidders who are desirous of participating in the subject tender shall submit their bids on or before 30.08.2025 at 01.00 pm. The bidders should enclose the prescribed copies in support of their bids. The bidder shall invariably furnish the bid security DD drawn in favour of "Superintending Engineer/OMC/Metro-West/TGTRANSCO/GTS Colony/Erragadda/ Hyd."
- 4.2 If any of the certificates, documents, etc., furnished by the bidder is/are found to be false / fabricated / bogus, the bidder will be blacklisted and his BID SECURITY forfeited.
- 4.3 Bid rates shall be furnished in the enclosed schedules only. There shall not be any deviation from the contents, description and quantity of the schedule. If the required documents, schedules, forms, supporting documents for Qualifying Requirements (both physical & Financial) are not furnished, the bid will be liable for rejection.
- 4.4 The Bidder has to quote the rates in Sch.-B.
- 4.5 All the bidders shall invariably furnish the DD for bid security and this will be the primary requirement to consider the bid as responsive.

- 4.6 Bids will be opened at the time, date and place indicated in the NIT.
- 4.7 The bidders shall carefully examine the specification and all its enclosures and if they have any doubt as to the meaning of any portion of the specification or enclosures thereto, they shall obtain the required clarifications from the officer to whom the bids are to be addressed.
- 4.8 Clarifications, amplifications, and/or any other correspondence from the bidder subsequent to the opening of bid will not be entertained. The bidders are therefore advised to ensure that their bids are uploaded in complete shape in the first instance itself. Post bid rebates, revisions or deviation in quoted price and/or conditions or any such offers which will give benefit to the bidder over others will not only be rejected straight but the original bid itself will get disqualified on this account and the bidder's bid security amount will be forfeited.

4.9 COMPLETENESS OF BID:

- a) The bid shall be quoted for all the works & all the items as per the bid specification.
- b) Part bids or incomplete bids will not be accepted and will be rejected.
- c) Superscription on the sealed cover
- i) Name of the work

Tenders which do not contain the above superscription on the sealed envelope shall be returned to the respective tenderers unopened without any consideration whatsoever.

5. **DETAILED SPECIFICATION**

The specification provides for "Painting of Firefighting Hydrant pipe lines, Hose pipe boxes, gate valves and staircase available at 400KV Kethireddypally SS".

- **5.1** The works involved are refilling of various types of fire extinguishers and supply of spares as directed by the TGTRANSCO Engineer in-charge at site.
- **5.2 RATE:** The rates (in Indian Rupees) quoted shall be for finished item of work and firm including all costs of labour and other costs associated with the completion of work.
- **5.3** Bidders are advised to find out the latest tax structure, applicability and rates before quoting. Further to reduce the billing difficulties, bidders are advised to round-off the basic prices and F & I to the nearest Rupee and taxes and duties to nearest two decimal places by using 'Round' formula in Excel sheets.
- **5.4 SITE VISIT:** The bidders are advised to visit and examine the site of proposed Substations and the route of transmission line and obtain all information that may be necessary for preparing the bid such as access to site, communication, transport, leads / and availability for water, sand, metal etc., right of way, the quantity of various items of work, the availability of local labour, availability and rates of materials, local working conditions, uncertainties of weather and period of crops and working seasons etc. The cost of visiting the site shall be at bidder's own expense. Ignorance of site conditions shall not be accepted by the Purchaser as basis for any claim for compensation at a later date. The submission of a bid by the bidder will be construed as evidence that such an examination was made and later claims/disputes in this regard shall not be entertained.
- **5.5** It is the responsibility of the bidder to satisfy himself that sufficient quantities of construction materials required for the works shall exist in the borrow areas or quarries sites. The TGTRANSCO does not accept any responsibility either in identifying the quarries or procuring the material or any other facilities in this regard. The bidder will not be entitled for any extra cost /rate or claim for the misjudgment on his part for quantity and quality of materials available in the quarries.
- **5.6** High Quality shall be maintained while executing the work and the contractor shall provide for any quality checks that may be stipulated by the engineer in charge.

5.7 BID SECURITY:

Bid Security equivalent to 2% of Estimated Contract Value (ECV) i.e., an amount of Rs.4,127/- shall be submitted by way of Demand Draft drawn in favour of "Superintending Engineer/OMC/Metro-West/TGTRANSCO/GTS Colony/Erragadda/ Hyderabad" payable at Hyderabad or through RTGS/IMPS (Bank details enclosed) scanned copy should be uploaded invariably. Tenders not accompanied by such D.D s towards Bid Security, are liable to be rejected. The Bid Security will be adjusted towards Performance Security in case of successful tenderer. No interest will be paid on Bid Security.

Bid Security is exempted for tenderers belonging to SC/ST categories. They must enclose Caste Certificate issued by Mandal Revenue Office along with the specification without which the tender will be rejected.

5.8 PERFORMANCE SECURITY:

The successful bidder shall furnish performance security equal to Five percent (5%) of the Contract Value for the proper fulfillment of contract to cover the 12 months guarantee period, within fifteen days of the award of contract and if he fails to do so, the Bid Security will be forfeited and the contract awarded will be cancelled without assigning any reasons there for. The bid security paid will be adjusted for part of performance security. The Performance Security will be released after 12 months after satisfactory completion of work entrusted which will not carry any interest. The Performance Security shall be forfeited, if the contractors do not fulfill the terms and conditions of works contract. The Performance Security shall be furnished by way of DD in favour of Superintending Engineer/OMC/Metro-West/Hyd.

5.9 AGREEMENT:

The successful Tenderers should enter into an agreement with TGTRANSCO within 30 days of acceptance of Performance Security on Non-judicial stamped paper for the value specified by the TGTRANSCO. If the contractor does not sign the agreement within 30 days of acceptance, the contract awarded will be cancelled.

5.10. PAYMENT:

Payments will be made up to 95% of the bills for the items of works completed during a month. For this purpose, the contractor shall submit monthly bills to the Divisional Engineer/ Executive Engineer concerned regularly to ensure payments in time. The contractor shall give full details of items of works done against each location in support of the bill. Bills submitted without supporting details will not be taken into cognizance.

The final 5% payment will be released after completion of the Guarantee period subject to settlement of material account.

Paying Officer is Superintending Engineer/OMC/Metro-West/Hyderabad.

Rates quoted shall be inclusive of all taxes. All statutory deductions will be deducted at source from the bills submitted for payment as per the relevant acts; Rules and Regulations there under at the rates prevailing at that time.

5.11 PENALTY:

The completion period committed shall be deemed to be the essence of the contract. In case of delay in completion of work, whatever be the reasons, the TGTRANSCO may at its option demand and recover from the Tenderer an amount equivalent to 0.5% of the value of the works not completed within the prescribed time limit for every week of delay or part thereof, subject to a maximum of 10% of the total value of the contract. Once the maximum is reached, TGTRANSCO shall consider termination of the contract. This right of TGTRANSCO shall be without prejudice to the rights under the law, including the right to cancel the contract, forfeit the deposit and recover damages for breach of contract.

In the event of termination of contract due to delay attributable to the contractor, TGTRANSCO is entitled to get back equipment / material from the contractor for the payment already made but the material is not put to use and then get the works done by the other agency / agencies for completion of contract by using the said recovered material. The contractor shall have no objection in the regard.

5.12 DEVIATION QUANTITIES:

The rates accepted for individual items of work covered under Schedule (Labour Portion) shall hold good upto 25% over the agreement quantities. For the quantities exceeding 25% over and above the agreement quantities, the rate payable will be TGTRANSCO estimate rate (or) accepted rates, whichever is less.

5.13 EXTENSION OF TIME FOR COMPLETION:

All additional works and variations ordered by the TGTRANSCO shall be completed within the contract time for completion of the section of the works to which they relate, unless the amount of extra or additional work of any kind whatsoever which may occur shall be such as fairly to entitle the contractor to an extension of time for completion in which case the TGTRANSCO shall determine the amount of such extension. Any extension of time so granted by the TS TRANSCO will only be given on the understanding that the extension of time completion shall not by itself the contractor to any extra payment for expenses by way of increased overheads.

5.14 SUPPLEMENTAL / NEW ITEMS:

The contractor is bound to execute all the supplemental / new items that are found essential incidental and inevitable during execution of main work. The rates for supplemental items shall be derived as per the current SSR rates during the period of execution +/- tender percentage whichever is less.
