The sample log sheets are available in the office of Superintending Engineer/OMC/Metro-East, West, Central circles.
- 2. All the schedules should be duly filled in. Unless full details required in the schedules are furnished, Tender offers will not be considered.
- 3. If the Tenderer has any doubt about the meaning of any portion of this specification, he should at once obtain the required clarifications/information in writing from the Chief Engineer/Metro Zone, TGTRANSCO, Opp. CTI, GTS Colony, Erragadda, Hyderabad 500045 from whom he has received the specification, before the date of tender after which no correspondence will be entertained. Only one tender will not be considered.
- 4. Submission of E.M.D by way of cheque, cash, money order, call deposit or Bank Guarantee will not be accepted.
- 5. Requests for exemption from payment of E.M.D will not be entertained in any case even though the Tenderers are registered with D.G.S & N.S.I.C. & S.S.I Units.
- 6. The E.M.D. will be refunded to unsuccessful Tenderers of application after intimation of the rejection of the Tender. The TGTRANSCO reserves the right to place orders for individual items with different Tenderers and to revise the quantities at the time of placing the order and to order extra materials upto the extent of the offered quantities within the validity of the Tender. After placing purchase order additional log sheets, if necessary will have to be supplied by agency on notified by TGTRANSCO.
- 17. It is not binding on TGTRANSCO accept lowest or any other bid it result the right to place on different bidder.

18. Penalty for late Delivery:-

i) General: The time for and the dates for delivery mentioned in the purchase order shall be deemed to be the essence of the contract. In case of delay in delivery of materials at destination. Whatever be the reason, the TGTRANSCO may at its option, demand and recover an amount equivalent to half percent of the value of the materials not delivered within the prescribed time limit for every week of delay or part thereof, subject to max of 5% of the total value of the contract.

This right of the TGTRANSCO shall be without prejudice to its rights under the law including the right to cancel the contract, forfeit the deposit and/or recover damages for breach of contract.

(ii) The date of receipt of materials at the destination stores in good condition (Form-13) will be taken as the date of delivery.

For penalty, the number of days of delay would be rounded off to the nearest week and interest calculated accordingly. Materials/equipment which are not of acceptable quality or are not conforming to specification would be deemed to be not delivered.

The penalty specified in this Clause shall be levied and would be adjusted against subsequent pending bills.

- 19. **Delivery Period:-** the delivery period is 2 months and this shall reckoned from the date of issue of detailed purchase order for the subject material.
- 20. The successful tenderer shall guarantee Quantity and Quality of material used.
- 21.TGTRANSCO reserves the right to accept or reject any bid, and to annual the bidding process and reject all bids at any time prior to contract award, without thereby incurring and liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders.

22. All and any disputes or differences arising out of or touching the order against this specification shall be decided only by the courts or tribunals situated in Hyderbad/Secunderabad Cities. No suit or other legal proceedings shall be instituted elsewhere

23. Force Majeure:

The supplier will not be liable for delay or for failing to supply the material/equipment for reasons of 'Force Majeure' such as acts of God, acts of Public enemy, acts of Govt., fires, floods, strikes, lockouts etc., and strikes in works of manufacturers of proprietary items as specified by the TGTRANSCO.

The supplier shall within 10 days from the beginning of such delay notify to the TGTRANSCO in wiring the cause of delay. The TGTRANSCO shall verify the facts and grant such extension of time as facts justify.

No price variation shall be allowed during the period of force majeure and penalty would not be levied for this period.
