## **TERMS & CONDITIONS**

**NAME OF THE WORK:** Dismantling and re-erection of slightly bent tower at Loc.No.124 in 132KV Budidampadu - Kallur/Thallada DC line in Lines SD/Budidampadu

- 1 The work is to be executed under the supervision of contractor's technical supervisor, as per the instructions of TGTRANSCO Engineer at site. The **Divisional Engineer/O&M/Budidampadu** is overall in charge of the work, The **Assistant Divisional Engineer/Lines/Budidampadu** is in charge of the execution of the work. The Superintending Engineer/ OMC Circle/Khammam are the paying officer.
- 2 The work should be started immediately and should be completed within (30) days from the date of handing over of site. The work should be carried out as per the schedule enclosed.
- 3 The materials/paints should be of high quality (ISI Make) arranged by the contractor at his own cost for which no extra amount will be paid
- 4 The materials purchased by the contractor should be handed over to the officer who is in charge of the work along with purchase bills and the materials will be released to the contractor on T-NOTE for the works.
- 5 The work is to be carried out carefully without coming in contact with insulators and live conductor.
- 6 If any accident occurs to the contractor's workmen during the course of execution of work, the contractor will be liable to pay the required compensation. If the contractor does not pay such compensation as settled by the courts or labour departments, the TGTRANSCO will recover the same from any of the bills of the contractor. TGTRANSCO in any case will not be directly responsible for payment of workmen's compensation.
- 7 Any disputes arising out of this contract shall be decided in the courts of law situated at Khammam.
- 8 The contractor should provide all statutory requirements and facilities to his workmen engaged at his own cost.
- 9 For any unauthorized work on any EHT line/substation without proper line clear from the Engineer of TGTRANSCO and accidents thereof, the contractor will be held responsible. Para (6) above regarding workmen's compensation will be enforced in this case also.
- 10 **PENALTY FOR LATE COMPLETION:** If the work is delayed, stopped or interrupted, without any valid reason to the satisfaction of TGTRANSCO Engineer, causing inconvenience and financial loss to TGTRANSCO, extension of time cannot be granted, when penalty clauses will be enforced. An amount equivalent to half percent 0.5% of value of the balance works remaining unexecuted as on the date per week of delay or part thereof, subject to a maximum of 5% of the total value of the contract will be recovered from the contractor. In case the contract is terminated, TGTRANSCO will forfeit the deposits.
- 11 Every care should be taken by the contractor while executing the work to see that no damage occurs to any equipment, cables, properties, T&P, etc., In case of any damage, the contractor shall be held to pay the damages thereof or alternatively rectify the same at his cost to the satisfaction of TGTRANSCO Engineer. Depending on the risks involved, the contractor may arrange general insurance for period of working, at his own cost.
- 12 An undertaking as in the Annexure shall be given by the company/firm/ contractor along with tenders, disclosing their relationship with the Officers/Directors of TGTRANSCO/ DISCOMS failing which the tender will be rejected. False information in the declaration will render the contract liable for termination as well on recovery of damages.
- 13 The contractor shall comply with all laws of State and Central Governments, statutory rules, regulations etc., such as payment of wages act, minimum wages act, workmen's compensation act, employee's liabilities act, industrial disputes act, etc., and EPF scheme etc., in force, during the tenure of contract period
- 14 If the work carried out is not satisfactory to the Superintending Engineer/OMC/TGTRANSCO /Khammam, the Superintending Engineer/ OMC/Khammam reserves the right to arrange execution of the balance works through any other agency, and recover such costs from any of the bills of the Contractor and to terminate the contract giving 7 days' notice.
- 15 **Security Deposit:** Contractor has to pay within 15 days from the date of issue of the Letter of Intent, an amount equal to 5% of the total value of the contract as security deposit for proper execution of and fulfilment of contract which will include the guarantee period of 12 months over and above the specified completion period, failing which the EMD paid by the contractor will be forfeited. The security deposit shall be paid in shape of DD drawn in favour of "The **Superintending Engineer/OMC/TGTRANSCO/Khammam**" No interest will be paid on security deposit. The security deposit will be released after completion of guarantee period with a claim period of six months thereafter.
- 16 The EMD will be refunded to the unsuccessful tenders after finalization of tenders. For successful tenders the EMD if separately paid for the tender will be adjusted towards the payment of security deposit. **PEMD of Rs.5,405/-** will not be accepted as per present rules and cannot be adjusted towards security deposit.

- 17 **The EMD will also be forfeited in the following cases.**
- 'a' When the successful tenderer does not comply with the authorization letter of Superintending Engineer, OMC Circle, Khammam for taking up the work. Any tender cannot be withdrawn during the process.
- 18 **Guarantee Period:** You shall give guarantee for satisfactory performance of the material supplied by you and also for the workmanship against faulty for a period of 12 months from the date of satisfactory completion of work.
- 19 **Terms of Payment:** The following terms of payment are only acceptable. Tenders received stipulating terms other than the following terms will be invalidated.  
Payments for the work will be made no earlier than 30days and 90% of the payment will be released against the submission of bills for the portion of the works completed. Out of the balance 10% amounts, 5% payments will be released after completion of all the works & submission of Material Accounts. The final 5% payments will be released after completion of the "Guarantee period" or on submission of BG for the equivalent value, valid for the "Guarantee period" along with 5% performance security BG to be furnished as per Clause 6.10 of the purchase manual. The performance guarantee period will be reckoned from the date of completion of the all the works.
- 20 The tender shall familiarize with site conditions and facilities such as electric supply arrangements (for fabrication/lighting etc.,) before quoting the rates accordingly.
- 21 The works under the contract shall be carried out in accordance with the standard specifications. Where the work done or any part thereof, does not, in the opinion of the concerned TGTRANSCO's Engineer confirm to the standard specifications, the work shall have to be redone by the contractor at no extra cost.
- 22 If the contractor has received any excess payment by oversight or if any amount is due to be paid to TGTRANSCO and if it is not possible to recover such amount under the contract, the same shall be arranged to be recovered from any other bills due to him/Bank Guarantee given by the contractor.
- 23 Any taxes/duties imposed by the Central/State Government or by local bodies on the works carried out shall be paid by the contractor. The standard GST Tax deductions will be made as per prevailing rules The contractor has to submit valid registration documents with the respective departments (PAN Card, GST registration) at the time of submission of tenders. The GST shall be paid only to the Contractor/Firms/Company having valid GST Registration and on production of valid proof of payment.
- 24 Any other terms and conditions as per TGTRANSCO GST Rules & Regulations, not covered herein will be binding on the contractor

## **General Terms and Conditions**

### **1.0 Bidders / Firms eligible to Bid:**

The Bidders / Firms who

- i) Possess the valid registration and satisfies all the conditions therein.
- ii) Are not blacklisted or debarred or suspended by the Government /any power utility for whatever the reason, prohibiting them not to continue in the contracting business.
- iii) Have complied with the eligibility criteria specified in the Clause 3 of General Terms & Conditions in Section -1 of this Specification are the eligible Bidders/Firms.

### **1.1 Bidders / Firms ineligible to Bid:**

- (i) A retired officer of the Govt. of TS or Govt. of India or TGTRANSCO or their subsidiaries' is disqualified from tendering for a period of two years from the date of retirement without the prior permission of the Parent Department. The contractor shall intimate the list of his employees who were retired from Government/TGTRANSCO along with the permission possessed from parent department.
- (ii) The Bidder who has employed any retired officer as mentioned above shall be considered as an ineligible Bidder.
- (iii) The contractor himself or any of his employee is found to be Gazetted Officer who retired from Government Service and had not obtained permission from the parent department for accepting the contractor's employment within a period of 2 years from the date of his retirement.
- (iv) The Contractor or any of his employees is found at any time after award of contract, to be such a person who had not obtained the permission of the Government as aforesaid before submission of the Bid or engagement in the Contractor's service.
- (v) Contractor shall not be eligible to Bid for works in TGTRANSCO where any of his near relatives are employed in the rank of Assistant Engineer or Assistant Executive Engineers and above on the Engineering side and Assistant Accounts Officer and above on the accounts side. The Contractor shall intimate the names of persons who are working with him in any capacity or are subsequently employed. He shall also furnish a list of Gazetted / Non-Gazetted State Government Employees related to him. Failure to furnish such information Bidder is liable to be removed from the list of approved contractors and his contract is liable for cancellation.

#### **Note: Near relatives include**

- a) Sons, step sons, daughters, and step-daughters.
  - b) Son-in-law and daughter-in-law.
  - c) Brother-in-law and sister-in-law.
  - d) Brothers and Sisters.
  - e) Father and Mother.
  - f) Wife / Husband.
  - g) Father-in-law and Mother-in-law
  - h) Nephews, nieces, uncles and aunts
  - i) Cousins and any person residing with or dependent on the contractor.
- vi) The Companies which are blacklisted by any other utility and whose promoters firms or companies were already blacklisted /debarred by any other utility shall be considered as ineligible bidder. Further, the bidder shall give an undertaking (as per Schedule V- (C) that, if the information furnished in this regard is found to be false at a later date the bidder will be made ineligible or the contract will be terminated.

### **1.2 Documents to be furnished for Qualification requirements of the Bidders:**

Attested copies of documents relating to the Registration of the firm, Registration as Electrical Licensed Contractor in T.S, Partnership deed, Articles of Association, Commercial Tax Registration / GST / TIN number, Latest Income Tax Clearance certificate / PAN number from IT Department, GST registration, excise department registration certificates, Labour department registration etc.

**Note:** The Partnership firms, which are registered as Contractors shall intimate the change in partnership deed, if any, as per GO Ms No.58, I & CAD, dt.23.4.2002 within one month of such change. Failure to notify the change to the registration authority in time will entail the firms to forfeit their registration and their Bid will be rejected. The intimation of change of partners if any and the acceptance by the Registration authority may be enclosed. Further the change if any in the official address, phone/fax numbers etc., shall be intimated.

1.3 Availability of key personnel for administration/site management and execution viz., technical personnel required for the work.

1.4 Qualification criteria for opening of the price bid: Should upload all the mandatory documents as specified in eligibility criteria/NIT and other wise bid will be treated as non-responsive.

Even though the Bidders are meeting the above qualification requirements, they are liable to be disqualified / debarred / suspended / blacklisted if they have

- a) Furnished false/fabricated particulars in the forms, statements and /annexure submitted in proof of the qualification requirements and/or
- b) Not turned up for entering into agreement, when called upon within the time specified in the letter of acceptance
- c) Record of poor progress such as abandoning the work, not properly completing the contract, inordinate delays in completion, litigation history or financial failures etc., and
- d) A history of criminal record in which the Bidder is involved if any.
- e) History of litigation with Government/TGTRANSCO during the last 5 years in which the Bidder is involved.
- f) Any wrong declaration or hiding of information on clause (vi) above shall be viewed seriously and such firms will be blacklisted /debarred.

1.5 Even while execution of the work, if found that the work was awarded to the Contractor based on false /fake certificates of experience, the Contractor will be blacklisted and work will be taken over.
