# General Terms and Conditions. Tender Specification No.P-03/2025-26 of SE/OMC/TGTRANSCO/Adilabad.

#### 1. SCOPE OF WORK:

This specification covers the manufacture, testing and delivery FADS (Free at Destination Stores) of the material as detailed in the schedule attached to the specification.

#### 2. ELIGIBILITY:

i) Bidder must be OEM

(OR)

ii) Its Authorized Dealer. In case the bidder is an authorised dealer, they must submit valid authorisation certificate issued by OEM

(OR)

- iii) The bidder in his name should have supplied the similar type of products elsewhere in TGTRANSCO /TSGENCO/DISCOMS/GOVERNMENT Departments (Central/State) in past 3 years.
- iv) Bidder shall furnish documentary proof for point (i), (ii) and (iii) (Copies of Purchase Orders).

#### 3. FINANCIAL INFORMATION:

Bidders shall furnish documentary proof establishing their financial capability (Turnover certificate issued by a charted accountant for the amount equivalent to or more than the total bid price) for both the past two financial years (i.e., for FY 2023-24& 24-25), excluding the current financial year (FY: 2025-26).

#### 4. PRICES:

- i) Prices should be Firm in rupees and should be FADS price inclusive of all taxes and handling charges and insurance to cover the transport to destination stores. Delivery of the materials are at 132KV SS Mancherial, TGTRANSCO and 220KV SS Nirmal as per delivery clause(18).
- ii) Bidder should quote basic price and GST in their respective columns. Price variation is not applicable for this purchase order.
- iii) It is the responsibility of the tenderer to inform himself of the correct rates of duties and taxes leviable on the materials at the time of tendering.
- iv) If the rates of statutory levies assumed by the tenderer are less than the correct rates prevailing at the time of tendering, the TGTRANSCO will not be responsible for such errors. If the rates of statutory levies assumed by the tenderer are later proved to be higher than the actual/correct rates prevailing at the time of tendering, the difference shall be passed on to the credit of the TGTRANSCO.
- **5. VALIDITY:** Prices quotes should be valid for 90 days from the date of opening of tender.

#### 6. SUBMISSION OF BIDS:

- a) Bid should contain the technical details of the material and commercial aspects of the bidder for checking the eligibility.
- b) These will include documents required as per clauses (2),(3) ,(8) and annexed technical specification to the tender specification duly signed by the bidder.
- c) It should contain the price schedule and EMD.

#### 7. EARNEST MONEY DEPOSIT:

- i) Tender should be accompanied by an Earnest Money Deposit (EMD) equal to 2 % of the ECV of material offered against the bid.
- ii) EMD should be submitted in bid envelope. For the bidders who do not qualify in technical evaluation, the EMD will be returned to the bidder after placing of purchase order.
- iii) If the bidder fails to submit the EMD or insufficient EMD in bid envelope, such bidder will not be considered for evaluation.
- iv) EMD should be in the form of a crossed demand draft drawn on the State Bank of India or any other nationalized bank payable in favour of the Superintending Engineer/OMC/ TGTRANSCO/ Adilabad payable at Mancherial.
- v) E.M.D. will be refunded to the unsuccessful bidders after finalization of tenders. For successful bidders, the EMD will be refunded after placing the Purchase Order.
- vi) EMD will be forfeited,
  - a) When the successful bidder does not accept the order after issue of letter of intent/acceptance letter.
  - b) When the successful bidder fails to furnish the security deposit within the specified period after issue of letter of intent/acceptance letter.
  - c) When the bidder alters his prices or withdraws his bid before the expiry of validity.

#### 8. OTHER INFORMATION TO BE FURNISHED IN BID ENVELOPE:

- i) Full description particulars and working drawings of the materials as per annexed technical specification. Information regarding the company manufactured or origin of materials used in the manufacture of the material intended for supply should be furnished. Drawings/catalogue/manuals should be provided along with offer.
- ii) Samples: The bidder shall submit sample for each type of item free of cost for technical evaluation. Upon finalisation of the tender, samples will be returned to all unsuccessful bidders. Samples of successful bidders will be returned after completion of supply of total PO quantity or adjusted in the last lot of material. The sample should be separately provided with due superscription of tender details.
- iii) Samples for each item shall be submitted along with Tender. Each sample shall be superscibed with "Name of the Supplier".
- iv) The test certificates as per the technical specification and stipulation of relevant Indian Standard shall be submitted along with the tender.

#### 9. EVALUATION CRITERIA:

- a) Tender received without documentary proof as mentioned at clause-2 (Eligibility), Clause-3 (Financial Information) & caluse-8 will be treated as not qualified and will not be considered for further price evaluation.
- b) If the technical details of the material furnished by the bidder are found not in accordance with the technical specification and/or drawings annexed to the tender specification, the tender of the bidder will be treated as technically not qualified and will not be considered for further price evaluation.
- c) If the bid does not accompany with sample or the sample provided by the bidder is found not complying with the technical specification and/or drawings annexed to the tender specification, the tender of the bidder will be treated as technically not qualified and their price Schedule will not be considered for further evaluation. The decision taken by the tender opening authority in accepting the sample is final.
- d) Those bidders who qualify in the Technical & Commercial Evaluation only will be considered for further Price evaluation.
- e) Evaluation will be done considering all the items as single tender.
- f) Where there is a discrepancy between the unit price and total price, the unit price will prevail and the total price will be corrected accordingly.
- g) Where there is a discrepancy between words and figures, the amount in words will prevail.
- h) Evaluation will be done based on the total price with applicable GST.
- i) L1 i.e., lowest price offered will be considered for placing purchase order.
- **10. QUANTITY TO QUOTE**: Suppliers would be required to quote for total Quantities of each item in full as indicated in the Specification.

#### 11. REJECTION:

- i) Bids received without EMD or insufficient EMD will be rejected.
- 12. ACCEPTANCE: Bidder who offers the lowest price will be accepted.
- 13. NEGOTIATIONS: Only L1 bidder will be called for negotiations.
- **14. VARIATION IN QUANTITIES:** The quantities are subject to variation i.e., increase or decrease, upto 50% of the tender quantities at the time of placing purchase order / during supply of materials.

# **15. SECURITY DEPOSIT:**

#### 16. PURCHASE ORDER:

- i) Successful bidder will be issued with purchase order after due payment of security deposit as mentioned at clause-15 and the successful bidder will then be called the supplier.
- ii) The supplier shall acknowledge the purchase order.
- iii) All the timelines for offering for inspection & witness of acceptance tests, for delivery and for penalty etc. commence from the date of acknowledgement of purchase order.

#### 17. TESTS ON MATERIAL:

- i) The latest test certificates containing the result of the tests as per the relevant ISS or other specification stipulated must be submitted to the SE/OMC/Adilabad, before delivery of the material, if the tenderer is addressed for submission of the same.
- ii) The tenderer should specifically mention about furnishing the manufacturer's test certificates and a specimen form of test certificate should be furnished along with the tender.

#### 18. DELIVERY:

- i) The materials shall be supplied within 60 days from the date of receipt of purchase order. Delivery of material should be made at 132KV SS Mancherial,TGTRANSCO (10Nos) and 220KV SS Nirmal, TGTRANSCO(5Nos)
- i) The Purchase Order shall be sent through Post/Courier service and also intimation will be sent through E-Mail or SMS to the Mobile Number indicated in his tender. It is informed that 03days will be allowed as grace days for postal delay.
- ii) Date of receipt of Purchase Order shall be mentioned in the invoice.
- **19. LABELING**: Material to be supplied shall be labeled with full details of Manufacture, capacities and other details as specified in the relevant ISS or other specification stipulated.

### **20. FORCE MAJEURE:**

- i) The Vendor will not be liable for penalty for late delivery, or Termination for default if and to the extent that its delay is the result of an event of Force Majeure.
- ii) For purpose of this clause, "Force Majeure" means an event beyond the control of the supplier and not involving the Supplier's fault or negligence and not fore seeable. Such events may include, but are not restricted to, wars or revolutions, fires, floods, epidemics, quarantine restrictions, lockdowns and freight embargoes.
- iii) If a Force Majeure situation arises, within 15 days from the date of eventuality, the Vendor shall notify the Purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Vendor shall continue to perform their obligations under the contract as far as it is reasonably practice, and will seek all reasonable alternative means for performance not prevented by the Force Majeure event.

#### 21.PENALTY FOR LATE DELIVERY:

- i) Failure on of the supplier to deliver the goods within the stipulated period set out in the contract will attract penalty @ 0.5% per week of delay or part thereof on the value of the undelivered portion, subject to a maximum of 5% of the purchase order value
- ii) If the penalty due to delay exceeds the specified maximum, the TGTRANSCO may consider cancellation of purchase order.
- iii) For the purpose of Penalty, the date of receipt of materials at the destination stores in good condition (date of check measurement as in Form-13) will be reckoned as the date of delivery.
- iv) The right of the TGTRANSCO shall be without prejudice to its right under the law including the right to cancel the contract, forfeit the deposit and or recover the damages for breach of contract.

#### 22. GUARANTEE PERIOD:

- i) The materials shall be guaranteed for satisfactory operation for a period of 18 months from the date of delivery or 12 months from date of commissioning or putting the material into use whichever is earlier
- ii) If during this period, any of the materials are found defective, they shall be repaired or replaced by the supplier free of cost to the TGTRANSCO within one month from the date of intimation.

#### 23. LOSS (OR) DAMAGE:

- i) External damages that or prima facie the result of rough handling in transit or due to defective packing will be intimated to the supplier within a fortnight of the receipt of the material.
- ii) Defects, damages or shortages of any internal parts which cannot ordinarily be detected on a superficial visual examination, though due to bad handling in transit or defective packing, would be intimated with in 2 months from the date of receipt of material.
- iii) In either case the damage/defective materials should be replaced by supplier at free cost.

# 24. TERMS OF PAYMENT:

- i) 100% payment to the supplier will be arranged within 30 days of receipt of the material in good condition at the destination stores and/or receipt of supplier's invoice in duplicate.
- ii) Documents to be submitted for payment:
  - a) GST tax invoice in prescribed format in duplicate
  - b) Form-13
  - c) Delivery challan with due certification of receipt of material and check measurement by the competent officers.
- iii) If the supplier receives any excess payments by mistake or if any amounts are due to TGTRANSCO due to any other reason and it is not possible to recover such amounts under the contract resulting out of this specification, the TGTRANSCO reserves the right to collect the same from any other amounts payable to the supplier or Bank Guarantees given by the supplier to the TGTRANSCO.

# 25. GOODS AND SERIVES TAX (GST):

- iii) Tax invoice shall contain SGST and CGST breakup (or IGST) along with HSN Code.
- iv) Suppliers who have opted for composition scheme in GST shall not charge GST in their invoice. Supplier shall submit the Bill of supply without charging GST stating on the top of their Bill of Supply that "Composition taxable person, not eligible to collect tax on supplies".
- v) The input tax credit claimed by registered taxable person should commensurate reduction in the price of goods and services supplied to TGTRANSCO.
- vi) GST TDS @ 2% will be recovered and remitted to Government (if applicable).
- vii) E-mail address shall be mentioned on the invoice to send TDS certificate.

#### **26.STATUTORY VARIATION:**

- Any variation up or down in statutory levy or new levies introduced after issuing of purchase order under this specification will be to the account of TGTRANSCO.
- ii) Where delivery schedule is not adhered to by the supplier and there are upward variation / revision after the agreed delivered date, the supplier shall bear the impact of such levies and if there is downward variation / revision the TGTRANSCO should be given credit to that extent.
- **27.JURISDICTION:** All and any disputes or differences arising out of or touching this contract will be decided by the Courts situated at Mancherial in Telangana State.

## 28. GENERAL:
