TERMS AND CONDITIONS

1. **NAME OF THE WORK:** Hiring of 1No. 3 Ton Van for transportation of Gang men, Line Material, Equipment, T&P etc for utilization of CBD gang stationed at for the period from 01.04.2026 to 31.03.2027 (**To be filled by tenderer**).
2. **Period of Contract:** Initially for 01.04.2026 to 31.03.2027 and renewable for a further period of Maximum two years if required by TGTRANSCO & subject to Past performance being satisfactory.
3. **Eligibility Criteria:**
 - a) The bidder should have vehicle proposed to be engaged in his/firms name (or) should have notarized lease agreement for the vehicle for the period of contract.
 - b) Previous engagement of vehicle for similar nature of work preferable.
4. **FILLING OF THE SCHEDULE:**

The tender schedule should be filled properly and signed on all pages and the rates should be quoted for the complete work as shown in the schedule. Total rates should be quoted in the space provided both in figures and words. Partial filling of schedule and incomplete schedules or unsigned schedules or unsigned schedules will be rejected.
5. **BID SECURITY:-**

Rs.17,700/- (Rupees Seventeen Thousand Seven Hundred Only) in the form of DEMAND DRAFT drawn in favour of SE/OMC/Metro-East circle payable at Hyderabad should be enclosed to the tender. Tenders not accompanied with the bid security DD will be rejected out rightly and no request will be allowed in this matter. The bid security will be refunded to the unsuccessful tenderer only after the finalization of the tenders.

The bid security of the successful tenderer will be adjusted towards the security deposit.
6. **Security Deposit:**

The successful tenderer shall furnish a security deposit equivalent to 5% of the total tender value for proper fulfillment of the contract. If contractor fails to furnish balance security deposit with in specified time, the EMD will be forfeited. No interest will be paid towards the security deposit. The security deposit will be released after the completion of the agreement period satisfactorily. The satisfactory certificate will be issued by the officer for whom the vehicle is provided. This will not be waived in any case under any circumstances. The security deposit will be forfeited if the contractor fails if he fails to carryout work entrusted as per terms & condition of work.
7. **Validity.**
 - a) The tender shall be valid for 90 days from the date of opening.
 - b) TGTRANSCO reserves the right to extend the validity of the tender.
8. **Model of Vehicle To be Engaged :-** upto 10Years old model as per specification.

9. **Ownership of the vehicle:-** The RC shall be in the name of the agency or its sole proprietor or should have a valid lease agreement during the period of contract.
10. A 3 Ton VAN is to be provided along with Driver (24 hours availability everyday during the contract period) and to be stationed along with the Gang OR as directed by the concerned AE/ADE. The said Van shall be in perfectly good running condition externally and internally both, with perfect front and rear suspension and with a hood made of Tarpaulin covering half portion of the body for seating of the labour and balance half portion open for carrying materials, T&P, etc.
11. The vehicle so provided shall be kept at the place specified along with the driver and all expenses of fuel, lubricants, Insurance (including for the persons carried by vehicle), taxes, driver wages shall be borne by the successful tenderer and the vehicle should be kept always in perfect running condition. The vehicle should be made available on holidays and festival days also. The vehicle can be requisitioned at any time during all the 24 hours of the day depending on the necessity. The vehicle shall be placed at the disposal of the requisitioning officer at a specified place within the time specified failing which penalty at the direction of the corporation will be levied
12. If the vehicle gives any trouble it should be repaired immediately and during its repair period, an alternate vehicle should be made available. In case of any breakdown of the vehicle on any day, if the successful tenderer fails to supply an alternate vehicle, a penalty at the rate mentioned in Clause 20 will be deducted from the monthly bills. Similarly, if the vehicle breaks down during a journey, the Gang traveling in the vehicle at that time, may engage another public or private conveyance to reach their destination and back, in which case the cost of such trip shall be reimbursed by the successful tenderer, or it will be recovered from hire charges bill for that particular month under prior intimation to the successful tenderer. The vehicle should be maintained in perfect condition and well upholstered. Good road worthy vehicle with perfect front rear suspension and comfortable seats is to be made available
13. The Van should be insured preferably under “Comprehensive Insurance”, if insured under “Act only policy”, in which case, it shall be total responsibility of the successful tenderer to indemnify the corporation against any loss or damage caused either to the occupants of the Van including driver or to the third party due to either rash driving of the driver or any other untoward incidents out of his control. The corporation will not be responsible for any tax dues or loans or debts of the successful tenderer on the vehicle and there shall not be any involvement of the Corporation, in such cases
14. The Van shall have the valid Fitness Certificate issued by the Road Transport Authority.
15. The vehicle will be required to go on trips, generally, to any of the towns and villages in the Districts covered in the entire state of Telangana or outside Telangana in case of exigencies.
16. The rate quoted in the schedule shall be firm include cost of Fuel, Lubricants, Insurances, Taxes, Driver wages, Repair / Replacement charges, etc., everything complete including the accommodation and boarding charges to the Driver.
17. The successful tenderer providing the vehicle and Driver has to comply with RTA Rules and should be in possession of necessary permission, license, etc., to ply the vehicle for conveyance of equipment, Gang men, T&P /Line material, etc.

18. The driver should possess valid driving license issued by the competent authority which he has to exhibit whenever asked for.
19. Driver should reside at the Head Quarters and should be available for making any trip to any place as assigned without detrimental to corporation works. The driver with the vehicle has to report to the concerned officer within specified time as required/directed every day including holidays
20. An amount of **Rs.1,000 (Rupees One Thousand only)** per day will be deducted from the monthly bills in the case of non-availability of vehicle and / or fails to provide alternate vehicle within a reasonable time as acceptable to TGTRANSCO officers concerned
21. The vehicle should fulfill all conditions of RTA like vehicle Tax, Insurance Road worthiness, and permit for carrying Men & Material. The vehicle should have permit to move anywhere in Telangana. However in exigencies, the vehicle may also be utilized for outside Telangana for TGTRANSCO works.
22. Trip Sheet book movement of the van with particulars of date/ time, distance in Km and journey shall be maintained by such tenderer. This shall be signed by the concerned ADE/AE or other officer utilizing vehicle.

23. Inspection:

The vehicle should be put up for inspection along with the original documents like RC (Registration Certificate), insurance policy, taxi permit, Valid pollution under control certificate etc. to the inspecting officer authorized by TGTRANSCO as and when requisitioned. The successful bidder shall make the vehicle available for inspection to concerned DE/O&M before actually providing the same to TGTRANSCO. Vehicles not conforming to this specification will be rejected.

24. Reckoning of KM's and Time:

The reckoning of KM's will be counted from the Head quarters or from the Garage of the agency (whichever distance is less) to the designated place by the officer using the vehicle.

The reckoning of hours will be from the time of reporting to the designated place and to the time of release by the officer

25. TGTRANSCO shall not be liable for payment of any penalties claimed by concerned authorities for all offences punishable under law.

26. Payment terms:

- a) The prices agreed shall be firm.
- b) Payment will be generally arranged monthly within reasonable time after submission of bill in duplicate along with the approved Trip Sheet.
- c) Income tax will be deducted as applicable on the date of payment.
- d) The paying officer is SUPERINTENDING-ENGINEER/OMC/ Metro-East circle
- e) No interest will be paid if the payments are delayed due to whatever reasons it might be.
- f) The monthly bills shall be submitted to concern ADE/AE CBD.
- g) Bank commission charges shall be to the contractors account.
- h) Exchange commission for issue of Bank Drafts will have to be on the account of the contractor.
- i) Whenever it is found that the tenderer has received any excess payment by mistake or if any amounts are due to TGTRANSCO due to any reason and when it is not possible to recover such amounts TGTRANSCO reserves the right to collect the same from any other amounts and bank guarantee/bid security/Performance security/EMD given by the tendered due to or with TGTRANSCO.

27. The Owner/Manager of the Agency providing vehicles to the field officers shall not be related to any of the employees and Officers/Directors of TGTRANSCO/DISCOMS/TGGENCO. An undertaking to this effect should be furnished by the contractor.
28. The hiring contract can be terminated without assigning any reason for un-satisfactory performance on the part of the traveling agency
29. The Contractor has to comply with R.T.A. Rules and rules of other agencies like Police, Labour rules etc., and should be in possession of necessary permission, License etc., to the Vehicle on hire.
30. The duty slip should be maintained and be available with driver for obtaining the TGTRANSCO officials' signatures for the trips made.
31. The contractor should implement minimum wages act for persons engaged by him for providing the vehicle to TGTRANSCO on hire basis.
32. The Contractor should give two months prior intimation to TGTRANSCO, if the contractor wants to withdraw the vehicle within the agreement period Or else the Security Deposit will be forfeited.
33. The Vehicle should display Yellow number plate.
34. Any disputes arising out of this contract have to be settled in the Hon'ble Courts of Jurisdiction situated in geographical jurisdiction of OMC/Metro East Circle only.
35. If the vehicle is withdrawn permanently without fulfilling the conditions of agreement causing inconvenience, action will be taken to forfeit the Security Deposit
36. **Liability:** TGTRANSCO shall not be responsible for any liability or damages suffered by the tenderer of the vehicle entrusted on hire or its driver during the course of the hire period while on TGTRANSCO works due to, accidents, demonstrations, riots, natural calamities, strikes, fire, etc.
37. Toll tax paid by the contractor for movement of 3 ton van engaged for TGTRANSCO work shall be reimbursed on production of proof payment of toll tax.
