

TERMS AND CONDITIONS
Section-A (General)
1. GENERAL INSTRUCTIONS TO THE BIDDERS

- 1.1 **General:** The TGTRANSCO invites bids for the works mentioned in the NIT and Project Data sheet for which dates and time specified in the NIT and will be opened by either bid inviting authority or his nominee at his office on the date and time mentioned in the NIT. The details of Bid inviting authority are mentioned in the Project Data Sheet.
- 1.2 The Bids should be in the prescribed form invited as specified in NIT as per specification.
- 1.3 The dates stipulated in the NIT are firm and under any circumstances they will not be relaxed unless officially extended by TGTRANSCO.
- 1.4 The estimated value of the works is given in the Schedule-A. The Bidder has to quote in Schedule-B, the percentage excess/ on par/ less on the total estimated value of the works given in the Schedule-A.
- 1.5 The successful Bidder is expected to complete the work within the time period specified in the Schedule- C.
- 1.6 TGTRANSCO reserves the right to cancel/extend/alter the bid & bid conditions at any time. In the process, if the tender process / works are stalled due to legal intervention or due to natural calamities, no compensation will be paid.

2.1 Bidders / Firms eligible to Bid:

- i) Are not blacklisted or debarred or suspended by the Government /any power utility for whatever the reason, prohibiting them not to continue in the contracting business.
- ii) The bidder shall possess valid registration of TGTRANSCO.
- iii) The bidder shall possess valid A-Grade License issued by the Electrical Inspectorate.
- iv) The bidder should have valid PAN card.
- v) The bidder should have valid GST registration
- vi) The bidder should have valid firm registration & partnership deed in case of firm
- vii) The bidder should have Similar work experience in TGTRANSCO.
- viii) This work is earmarked for SC community. Individuals belonging to 'SC' community recognized under SC category by Govt. of Telangana are only eligible to participate in the tender. The bidder should submit the caste certificate issued by competent authority.

2.2 FINANCIAL TURNOVER:

- a. Bidder should have achieved an annual turnover equal to 100% of the value of the works proposed in the bid specification in any continuous period of 12 months during the last five financial years including current financial year duly certified by competent authority.
- b. The bidder should enclose documentary evidence of works executed in the name of bidder only for the turnover claimed.
- c. The bidder in his name should have successfully executed Similar works in last 5 years as on the date of bid opening as prime contractor and which will be in satisfactory operation for at least one year as on date of bid opening issued by not less than Divisional Engineer.

The bidder shall meet the qualification requirements mentioned notified item. The bidder should furnish documentary evidence in support of the qualifying requirements stipulated as above certified by Order Placing authority of the concerned Power utility/Government Organizations.

- 3.1 Even though the Bidders meet the above qualification requirements, they are liable to be disqualified / debarred / suspended / blacklisted if they have
- a) Furnished false / fabricated particulars in the forms, statements and / annexures submitted in proof of the qualification requirements and/or
 - b) Not turning up for taking up the work within 15days from the date of LOA or intimation of taking of handing over of site and/or
 - c) Not turned up for entering into agreement, when called upon within the time specified in the letter of acceptance.
 - d) Record of poor progress such as abandoning the work, not properly completing the contract, inordinate delays in completion, litigation history or financial failures etc., and
 - e) A history of criminal record in which the Bidder is involved if any.
 - f) History of litigation with Government/TGTRANSCO during the last 5 years in which the Bidder is involved.

3.2 Bidders / Firms ineligible to Bid:

- (i) A retired officer of the Govt. of TS or Govt. of India executing works is disqualified from tendering for a period of two years from the date of retirement without the prior permission of the Government.
- (ii) The Tenderer who has employed any retired officer as mentioned above shall be considered as an ineligible tenderer.
- (iii) The contractor himself or any of his employee is found to be Gazetted Officer who retired from Government Service and had not obtained permission from the Government for accepting the contractor's employment within a period of 2 years from the date of his retirement.
- (iv) The Contractor or any of his employees is found at any time after award of contract, to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the Contractor's service.
- v) Contractor shall not be eligible to tender for works in TSTRANSCO where any of his near relatives are employed in the rank of Assistant Engineer or Assistant Executive Engineers and above on the Engineering side and Assistant Accounts Officer and above on the accounts side.
- vi) The Contractor shall intimate the names of persons who are working with him in any capacity or are subsequently employed. He shall also furnish a list of Gazetted /Non-Gazetted State Government Employees related to him.
- vii) Failure to furnish such information tenderer is liable to be removed from the list of approved contractors and his contract is liable for cancellation.

Note: Near relatives include

- a) Sons, step sons, daughters, and step-daughters.
- b) Son-in-law and daughter-in-law.
- c) Brother-in-law and sister-in-law.
- d) Brothers and Sisters.
- e) Father and Mother.
- f) Wife / Husband.
- g) Father-in-law and Mother-in-law
- h) Nephews, nieces, uncles and aunts
- i) Cousins and any person residing with or dependent on the contractor.

4. SUBMISSION OF BIDS:

4.1 The bidders who are desirous of participating in the subject tender shall submit their bids on or before **10.04.2026 at 01.00 pm**. The bidders should enclose the prescribed copies in support of their bids. The bidder shall invariably furnish the Specification Cost by way of DD drawn in favour of "**Superintending Engineer/ OMC/Metro-West/ Hyd.**" (or) RTGS payment receipt.

4.2 If any of the certificates, documents, etc., furnished by the bidder is/are found to be false / fabricated / bogus, the bidder will be blacklisted.

4.3 Bid rates shall be furnished in the enclosed schedules only. There shall not be any deviation from the contents, description and quantity of the schedule. If the required documents, schedules, forms, supporting documents for Qualifying Requirements (both physical & Financial) are not furnished, the bid will be liable for rejection.

4.4 The Bidder has to quote the rates in Schedule-B.

4.5 All the bidders shall invariably furnish Caste Certificate issued by competent authority, failing at which the bids will be liable for rejection.

4.6 Bids will be opened at the time, date and place indicated in the NIT.

4.7 The bidders shall carefully examine the specification and all its enclosures and if they have any doubt as to the meaning of any portion of the specification or enclosures thereto, they shall obtain the required clarifications from the officer to whom the bids are to be addressed.

4.8 Clarifications, amplifications, and/or any other correspondence from the bidder subsequent to the opening of bid will not be entertained. The bidders are therefore advised to ensure that their bids are uploaded in complete shape in the first instance itself. Post bid rebates, revisions or deviation in quoted price and/or conditions or any such offers which will give benefit to the bidder over others will not only be rejected straight but the original bid itself will get disqualified on this account and the bidder's bid security amount will be forfeited.

4.9 Each Tenderer shall submit only one Bid for the work. A Tenderer who submits more than one Bid will cause dis-qualification of all the Bids submitted by the Tenderer.

4.10 The Tenderer shall bear all costs associated with the preparation and submission of his Tender and the tender inviting authority will in no case be responsible and liable for those costs.

4.11 COMPLETENESS OF BID:

- a) The bid shall be quoted for all the works & all the items as per the bid specification.
- b) Part bids or incomplete bids will not be accepted and will be rejected.
- c) Superscription on the sealed cover :
 - i) Name of the work
 - ii) Tender Specification No.
 - iii) Details of Tender Specification cost (D.D. No. / UTR No., Amount etc.) enclosed
 - iv) Vender Registration Number with TGTRANSCO, if any.
 - v) Tender opening time & date
 - vi) Validity of Tender from the date of opening (90 days validity is required)

Tenders which do not contain the above superscription on the sealed envelope shall be returned to the respective tenderers unopened without any consideration whatsoever.

5. DETAILED SPECIFICATION

The specification provides for “**Painting of Firefighting pipes and Hose pipe boxes, etc., at 400 / 220kV Shankarpally Substation**”.

5.1 The works involved are Painting of Firefighting pipes of 400kV ICTs and 400kV Reactor and Hose pipes boxes etc., available in Firefighting rooms and switchyard at 400/220kV Shankarpally Substation with primary coat of red-oxide followed by ready mixed 1st quality synthetic enamel paint applied with brushes and spray paint wherever it is necessary as directed by the TGTRANSCO Engineer in-charge at site, including costs brushes, conveyance of all material to the site and labour charges etc., complete finished item of work.

5.2 RATE: The rates (in Indian Rupees) quoted shall be for finished item of work and firm including all costs of labour and other costs associated with the completion of work.

5.3 Bidders are advised to find out the latest tax structure, applicability and rates before quoting. Further to reduce the billing difficulties, bidders are advised to round-off the basic prices and F & I to the nearest Rupee and taxes and duties to nearest two decimal places by using ‘Round’ formula in Excel sheets.

5.4 SITE VISIT:

The bidders are advised to visit and examine the site of proposed Substation and obtain all information that may be necessary for preparing the bid such as access to site, communication, transport, leads / and availability for water, sand, metal etc., right of way, the quantity of various items of work, the availability of local labour, availability and rates of materials, local working conditions, uncertainties of weather and working seasons etc. The cost of visiting the site shall be at bidder’s own expense. Ignorance of site conditions shall not be accepted by the Purchaser as basis for any claim for compensation at a later date. The submission of a bid by the bidder will be construed as evidence that such an examination was made and later claims/disputes in this regard shall not be entertained.

5.5 It is the responsibility of the bidder to satisfy himself that sufficient quantities of materials required for the work shall exist in the borrow areas or sites. The TGTRANSCO does not accept any responsibility either in procuring the material or any other facilities in this regard. The bidder will not be entitled for any extra cost /rate or claim for the misjudgment on his part for quantity and quality of materials available in the quarries.

5.6 High Quality shall be maintained while executing the work and the contractor shall provide for any quality checks that may be stipulated by the engineer in charge.

5.7 BID SECURITY:

EMD exempted As per T.O.O (CE/Civil), Ms.No. 511, Dt. 03-01-2020.

Exemption of EMD:

- (i) Exemption of EMD shall be for the works costing upto 1.00 Crore (ECV) for SC’s/ST’s, Waddera Sagara (Uppara) contract co-operative societies and individuals for works in TGTRANSCO.
- (ii) However, in order to provide level playing field to all, EMD will be recovered from running bills after expenditure of 25% of the concerned works. This will also inculcate the responsibility for completion of the works.

5.8 PERFORMANCE SECURITY:

The successful bidder shall furnish within 15 days from the date of issue of preliminary acceptance letter or the Letter of Intent, performance security equal to FIVE PERCENT (5%) of the total accepted bid value for the proper execution and fulfillment of contract which will include the guarantee period of 12 months over and above the specified completion period. EMD to be paid will be adjusted after 25% of expenditure of the concerned work in 5% performance security as per T.O.O. CE(Civil), Ms. No. 511, Dt. 03-01-2020 i.e., 3% of quoted value shall be paid at the time of agreement and balance 2% after completion of 25% of works from running bill.

If the bidder fails to furnish the performance security as specified within 15 days from the date of issue of preliminary acceptance letter or the Letter of Intent, the contract is liable for cancellation and forfeiture of the bid security. The performance security shall also be forfeited if the successful tenderer fails to fulfill the terms of the contract.

Performance security may be made by Demand Draft from any Nationalized Bank/Scheduled Bank in the Headquarters in favour of Superintending Engineer/ OMC/Metro-West/Hyderabad

Performance Guarantee period covers a period of 12 months guarantee for satisfactory performance and also for the workmanship against faulty erection/civil/painting works for a period of 12 months from the date of handing over of site / conclusion of work including claim period of 4 months and the formal acceptance of completed work by TGTRANSCO.

5.9. ADDITIONAL SECURITY DEPOSIT:

The rate quoted by the bidder less by more than 10% of the TGTRANSCO's total estimated cost will be considered as abnormally low rate. In the case of abnormally low quoted rates i.e., less than 10%, additional security deposit (ASD) to be paid for the less percentage below 10% i.e., if the bidder quotes 20% below the total estimated cost, then he has to pay ASD equivalent to 10% of the total estimated cost. This ASD amount will not be accepted by Bank Guarantee, Cheque, Cash or money order. It shall be paid by way of crossed demand draft on any scheduled/Nationalized bank drawn in favour of Superintending Engineer/OMC/Metro-West/Hyderabad which will be released after the completion of work in full shape.

5.10 AGREEMENT:

The successful Tenderers should enter into an agreement with TGTRANSCO within 30 days of acceptance of Performance Security on Non-judicial stamped paper for the value specified by the TGTRANSCO. If the contractor does not sign the agreement within 30 days of acceptance, the contract awarded will be cancelled.

5.11 PAYMENT:

Payments will be made up to 90% of the bills for the items of works completed during a month. For this purpose, the contractor shall submit monthly bills to the Divisional Engineer/ Executive Engineer concerned regularly to ensure payments in time. The contractor shall give full details of items of works done against each location in support of the bill. Bills submitted without supporting details will not be taken into cognizance.

Out of balance 10% the 5% payment will be released after completion of all the works subject to settlement of material account. The balance 5% payment will be released along with the performance Guarantee.

Paying Officer is Superintending Engineer/OMC/Metro-West/Hyderabad.

Rates quoted shall be inclusive of all taxes. All statutory deductions will be deducted at source from the bills submitted for payment as per the relevant acts; Rules and Regulations there under at the rates prevailing at that time.

5.12 PENALTY:

The completion period committed shall be deemed to be the essence of the contract. In case of delay in completion of work, whatever be the reasons, the TGTRANSCO may at its option demand and recover from the Tenderer an amount equivalent to 0.5% of the value of the works not completed within the prescribed time limit for every week of delay or part thereof, subject to a maximum of 5% of the total value of the contract. Once the maximum is reached, TGTRANSCO shall consider termination of the contract. This right of TGTRANSCO shall be without prejudice to the rights under the law, including the right to cancel the contract, forfeit the deposit and recover damages for breach of contract.

In the event of termination of contract due to delay attributable to the contractor, TGTRANSCO is entitled to get back equipment / material from the contractor for the payment already made but the material is not put to use and then get the works done by the other agency / agencies for completion of contract by using the said recovered material. The contractor shall have no objection in the regard.

5.13 DEVIATION QUANTITIES:

The rates accepted for individual items of work covered under Schedule (Labour Portion) shall hold good upto 25% over the agreement quantities. For the quantities exceeding 25% over and above the agreement quantities, the rate payable will be TGTRANSCO estimate rate (or) accepted rates, whichever is less.

5.14 EXTENSION OF TIME FOR COMPLETION:

All additional works and variations ordered by the TGTRANSCO shall be completed within the contract time for completion of the section of the works to which they relate, unless the amount of extra or additional work of any kind whatsoever which may occur shall be such as fairly to entitle the contractor to an extension of time for completion in which case the TGTRANSCO shall determine the amount of such extension. Any extension of time so granted by the TS TRANSCO will only be given on the understanding that the extension of time completion shall not by itself the contractor to any extra payment for expenses by way of increased overheads.

5.15 SUPPLEMENTAL / NEW ITEMS:

The contractor is bound to execute all the supplemental / new items that are found essential incidental and inevitable during execution of main work. The rates for supplemental items shall be derived as per the current SSR rates during the period of execution +/- tender percentage whichever is less.
