TERMS & CONDITIONS**

Name of the work: Providing of utility vehicle for official use of ADE / MRT/ Karimnagar sub division for the period from 01.06.2026 to 31.03.2027.

1. **Eligibility:** The bidder should be owner of the vehicle or should have a valid lease agreement for utilizing the vehicle for the FY 2026-27.

2. **EARNEST MONEY DEPOSIT (Bid Security):**

EMD @2% of the total value of the work offered against the bid to be paid by the way of Demand Draft drawn in favour of “Superintending Engineer/OMC/ TGTRANSCO/ Karimnagar” should be enclosed to the tender. Tenders not accompanied by such D.D towards Bid Security, are liable to be rejected.

The EMD will be refunded in the case of unsuccessful Tenderers after finalization of tenders.

No interest will be paid on Bid Security.

EMD is exempted for Tenderers who belongs to SC/ST Categories. A copy of Caste Certificate issued by Tahsildar should be enclosed along with the specification, without which the tender will be rejected.

3. **Documents to be submitted with bid: -**

- a) Registration Certificate in the name of the bidder, if owned by the bidder.
- b) Registered/Notarized Lease document, if leased vehicle.
- c) State vide Permit as applicable.
- d) Insurance.
- e) Tax.
- f) Vehicle Fitness.
- g) Pollution under control certificate.

4. Age of the vehicle shall be less than 10 years.

5. **Evaluation:**

- i) Tender will be evaluated taking the applicable taxes into consideration.
- ii) If a bidder quotes for more than one tender with same vehicle papers and qualifies as L1 bidder in more than one tender, it will be construed that he is capable of providing vehicle against any one tender only and the lowest of the bids will be considered and awarded to him and his bids will be considered as disqualified for other tenders.

6. Rejection of Bid:-

- a) If proof of EMD is not enclosed.
- b) If the documents mentioned at point 3 are not enclosed.
- c) The tender quoted more than 5% will be rejected.

7. Security Deposit:

- (i) Security deposit at 5% of face value of the contract shall be paid for proper fulfilment as per terms & conditions of the contract conditions.
- (ii) The security deposit will be released after completion of agreement.

General Terms and Conditions

8. The Vehicle should be kept at the places specified along with driver and all expenses on fuel, lubricants, insurance, taxes, driver wages, battery etc shall be borne by the contractor and the vehicle should be kept in running condition always.
9. Payment as per schedule rate will be paid up to the mileage of 2500 KM per month.
10. The Vehicle may be requisitioned at any time depending upon the necessity. The vehicle shall be placed at the disposal of the officer concerned.
11. The vehicle shall be made available on holidays and festival days also.
12. The Contractor should note that time is the essence of the contract since TGTRANSCO is an organization with emergency work and hence shall endeavour to see that the vehicle reaches the location in time.
13. The Driver of the vehicle shall be cooperative with the TGTRANSCO officials since the nature of the work may be at odd hours and at far off places.
14. The vehicle should be insured to cover any risk & accidents including vehicle, driver & officer including third party insurance. Under no circumstances the TGTRANSCO shall be responsible for any damages.
15. Group Insurance for Drivers:
Bidders who intends to supply more than one vehicle by providing drivers, should ensure that the drivers shall be covered under a group insurance policy and submit the relevant documents before providing the vehicles.
16. TGTRANSCO will not be held responsible for any taxes, loans or debts on the vehicles and should ensure no involvement of the TGTRANSCO on such counts.
17. The contractor shall maintain logbook with the driver and arrange for obtaining the signature of the TGTRANSCO official for the trips made.

18. Vehicle provider shall not lease his vehicle during that period of contract. If found, agreement will be terminated after processing of new tenders for the same vehicle. The vehicle provider will be debarred from participating in any tenders of TGTRANSCO for 2 years.
19. The vehicle bidder shall invariably provide the same vehicle for which documents are submitted while bidding. Any change in vehicle should have the prior approval from the agreement authority (SE/OMC/Karimnagar) with due intimation of at least 15days in advance. The decision taken by the agreement authority is final.
20. **Log Sheet:** A consolidated bill for the vehicle duly supported by the log sheet for each month is to be submitted in duplicate to the controlling officer i.e., by 5th of every succeeding month for arranging payment.
21. **Payment:**
 - a) 100% payment will generally be arranged for the value of the service rendered within one month from the date of receipt of the bill in complete shape. However, if delayed, no interest will be paid.
 - b) If the contractor has received any excess payment by mistake or if any amounts from the TGTRANSCO due to any other reason, when it is not possible to recover such amounts under the Contract recovering the same from any other amounts and Bank Guarantee given by the contractor due to or with the TGTRANSCO.
22. **Toll gate charges:**
 1. Toll gate charges shall be borne by the vehicle supplier preferably by having FASTAG.
 2. If FASTAG is not provided, Toll gate charges will be limited to original rates. Double the original rates will not be reimbursed.
 3. Proof of payment of tolls charges shall be submitted for reimbursement.
23. **Liquidation damages:** Due to non-fulfilment of the contract conditions, if any loss is caused to TGTRANSCO works, liquidated damages not exceeding 10% of the total value of the contract is liable for recovery from the contractor's bills and the agreement will also be terminated, if there is continued default.
24. **Period:** This contract covers period from 01.06.2026 to 31.03.2027 and on yearly renewable basis up to 31-03-2029 at the discretion of the SE/OMC/Karimnagar depending on the performance of vehicle and contractor. However, even if the performance is reported not satisfactory and/or the contractor is not willing to continue providing the vehicle within the agreement period, the contractor shall continue to provide the vehicle until specific termination order is issued.

If the vehicle is withdrawn permanently without fulfilling the conditions of agreement causing inconvenience, security deposit will be forfeited.

In case the vehicle provider expresses unwillingness to continue providing the vehicle at anytime during the period of contract, the bid submitted by that vehicle provider for the same vehicle proposed to be provided to the same officer will not be accepted in subsequent tenders up to 2 years.

25. **Leave:** In case the officer concerned proceeds on long leave or transferred and the post is vacant for a period of more than one month, the available hired vehicle shall be discontinued till a regular incumbent assumes charge.
26. The contractor shall comply with R.T.A. rules and he should be in possession of necessary permission/licences etc., to ply the vehicles for TGTRANSCO.
27. A licensed driver with badge has to be provided by the contractor.
28. The vehicle with commercial registration and state wide permit as applicable will only be considered for hiring.
29. In case of vehicle becoming sick, a vehicle in good condition is to be provided immediately.
30. TGTRANSCO is not responsible for any type of damages to vehicle property or personnel due to accidents.
31. The Superintending Engineer/OMC/Karimnagar reserves the right to cancel the tender process at any stage if required and bidders shall not have right to ask for reasons.
32. **Income tax:** Income tax will be deducted as applicable from the bills.
33. **GST:**
 - For registered vehicle supplier:**
 - a) GST @ 18% under FCM is applicable for any registered supplier under GST.
 - b) GST No of TGTRANSCO is 36AAFCT0166J1Z9 and should be quoted on the invoice.
 - c) The GST registration number of the Vendor has to be quoted on the invoice.
 - d) The invoice shall contain CGST and SGST (or IGST) along with HSN Code.
 - e) Vendors who have opted for composition scheme in GST should state on the top of their "Bill of Supply" that "Composition taxable person, not eligible to collect tax on supplies".
 - f) The input tax credit claimed by registered taxable person should commensurate reduction in the price of goods and services supplied to TGTRANSCO.
 - For unregistered vehicle supplier:**
 - a) GST is not applicable for unregistered suppliers.
 - b) Invoice shall be submitted for payment.
 - c) Unregistered vendor shall not claim GST in his invoice.

d) TDS @ 2% for GST will be recovered (for contract values more than Rs.2,50,000.00/-) and remitted directly to the Government as per Section 51 of CGST / SGST Act, 2017 and Section 20 of IGST Act, 2017 read with Notification No. 33/2017 – Central Tax, Dt. 15-09-2017 and Notification No. 50/2018 – Central Tax, Dt. 13-09-2018.

e) e-mail address shall be mentioned on the invoice to send TDS certificate.

34. **Penalty:** If the vehicle gives trouble, it should be got repaired within one hour of information. An alternate vehicle in good road worthy condition should be made available at site if the repair is getting delayed beyond one hour failing which TGTRANSCO will arrange alternate vehicle and cost incurred at actual will be recovered from the contractor.

In addition to the above, a penalty of Rs. 500/- (Rupees Five hundred only Non-Refundable) per day will be levied for failure to provide the alternate vehicle at the discretion of controlling officer.

35. **Extra KMs:** Approval from Chief Engineer/Transmission/Vidyut Soudha/Hyderabad is required for extra KMs run to claim the bill.

36. **Verification of Certificates:** Contractors shall ensure validity of vehicle document i.e., Registration certificate, State wide permit, Insurance, Vehicle Fitness, Pollution Under Control certificate and Badge for Driver from time to time and Controlling officer shall verify the same with originals.

37. **Certificates in bill: -**

- i) Contractors shall ensure validity of vehicle document i.e., Registration certificate, State wide permit, Insurance, Vehicle Fitness, Pollution Under Control certificate and Badge for Driver from time to time.
- ii) Agreement authority will verify the same at the time of entering into Agreement.
- iii) Subsequent renewals will be verified by Accounts wing. If any certificate is found lapsed, a penalty (non-refundable) of Rs.500 will be deducted from the bill in that month.
- iv) Subsequent bills will not be paid unless the certificate is renewed.
