Accordingly, he had assumed charge of the above post on 05-03-2012 AN

As per orders issued in the reference 3rd cited for deputation of Sri K.Ranganatham, JMD(Distribution)/AP Transco for inspection of 220 KV and 132 KV Cables and accessories at M/s.SFC, China and 68 Nos. insulation units at M/s. Viscas Corporation, Japan for a period of 12 days he has relinquished the additional charge of the post of JMD (Vigilance & Security)/AP Transco on 27-6-2012 AN.
