Sub: TSTRANSCO-IR- IR Section – Ban on Single use plastic material in the premises of TSTRANSCO Offices – Save Environment from Plastic - Reg.

In the G.O cited, the Government of Telangana has prohibited the usage/bringing of plastic carry bags with less than 50 microns in thickness and plastic carry bags made of recycled plastics for storing, carrying, dispensing or packing food stuff as per the Environment (Protection) Act, 1986 (Act No. 29 of 1986) & Plastic Waste (Management and Handling) Rules, 2016. It is a constant endeavor of TSTRANSCO to create a eco-friendly environment. The following orders are hereby issued for enforcement in TSTRANSCO Offices:

- i. Ban on single use plastic in the offices of TSTRANSCO such are plastic plates, Dishes, Spoons, Cups, Glasses, Straws, Carry bags, Containers, Wrappers, Mineral Water Pouches(Packets), Disposable water bottles, Food packing items etc.
  - ii. Employees should reduce and refuse plastic products and to use inexpensive reusable bags to reduce plastic footprint.
2. All the Heads of Departments of TSTRANSCO are hereby directed to communicate the above instructions to employees working under their control for strict implementation with immediate effect to create a eco-friendly environment.
