In continuation to the orders issued in the circular 2<sup>nd</sup> cited, the following orders shall be implemented in the Offices of TSTRANSCO and TSGENCO:

- Employee tested positive will be permitted to attend office only after the production of Covid negative Report.
  - Help Desk shall be the concerned Chief Vigilance Officer and Co-ordination, Credit facility etc., by the Doctors of TSGENCO / TSTRANSCO and TSDISCOMS
  - Concerned Medical Sections of TSTRANSCO and TSGENCO shall extend all facilities for In-patient treatment of COVID-19 by co-ordination with hospitals, issue of Credit Cards, etc. The Credit cards shall be issued first from SFMS followed by General Ceiling. After this amount is exhausted, credit card has to be issued under major ailment / major ceiling.
  - This facility shall be extended with rates mentioned in G.O.Rt. No. 248, dt.15.6.2020/ NIMS / CGHS.
  - Information in the enclosed Format has to be sent by all the Zones/Circles/ Generating Stations including Corporate Office by 3.00 P.M, to the concerned Medical Sections and Chief Vigilance Officers of TSTRANSCO and TSGENCO.
  - Chief Engineers of the concerned Zones / Generating Stations are the Nodal Officers for sending the above information.
2. These orders shall come into effect from 01.07.2020 and shall be in force till further orders.


