Sub: TGTRANSCO – Loans and Advances – House Building Advances – Sanction of repayment of Loan raised from other agencies to build a House or Acquire a Flat/ Ready Built House – Orders – Issued.

Ref:- 1. B.P.(P&G-B.M(Loans) Ms.No.268, dated.10.08.1992.

 Memo.No.Jt.Secy/DS(Per-I)/AS(Per-I)/PO(IR&R)/JPO-Re/232/16, Dt.19.01.2017.

In the B.P. 1<sup>st</sup> cited, the erstwhile APSEB issued orders extending the facility to its employees for utilization of the amount of House Loans taken from other agencies, like LIC of India, HUDA, HUDCO etc., to build a house or acquire a ready built house/flat. The said concession shall be extended even where the construction was commenced subject to the terms and conditions mentioned therein satisfied by the sanctioning authority.

- 2. In memo 2<sup>nd</sup> cited, TRANSCO has extended the same facility to its employees, for utilization of the amount of House Building Advances, for purpose of repayment of the other loans taken from Banks i.e., ICICI, IDBI and HDFC to build a house or acquire a ready built house/flat.
- 3. Certain Employees Associations of TGTRANSCO have requested for sanction of House Building Advance (Takeover Loan) to TGTRANSCO employees who availed Home Loan from SBI and other similar Banks.
- 4. After careful examination, the TGTRANSCO has decided to extend the same facility to its employees, for utilization of the amount of House Building Advances, for purpose of repayment of the other loans taken from Banks i.e., SBI & Nationalized banks to build a house or acquire a ready built house/flat. The concession shall be extended even where the construction was commenced subject to the following terms and conditions, which must be satisfied by the sanctioning authority:
  - i) The TGTRANSCO Employees shall ensure that only after he/she has applied for House Building Advance and he/she must be in the order of seniority and came up for sanction and the same was not sanctioned to him/her, due to paucity of funds.
  - ii) Should satisfy himself/herself that the other loans were taken by the TGTRANSCO employee entirely, for the purpose of construction/purchase of ready built house/flat.
  - iii) Should ensure that the house building advance sanctioned is limited to the amount of loan still due to be repaid by the TGTRANSCO employee. In this regard the loanee should submit a certificate obtained from the Agency concerned.
  - iv) The TGTRANSCO employee has to fulfill the other formalities of the House Building Advance rules and conditions mentioned in the sanction order.

- 5. All other conditions regarding the sanction of House Building Advance (Takeover Loan) shall be continued to be inforce.
- 6. These orders are issued with the concurrence of the Joint Managing Director (Fin., Comml., & HRD) vide Regd.No.894, dt.15.03.2025.
