The State Election Commission issued Notification No. 660/TGSEC-PR/2023-1, dated 29-9-2025 for conduct of 2nd Ordinary Elections to the Gram Panchayats of the State of Telangana, which was published in the Extraordinary Gazette No. G-761/1, dated 29-9-2025.

The Notification No. 660/TGSEC-PR/2023-4, dated 9-10-2025 was issued by the State Election Commission, keeping in abeyance the Election Notification No. 660/TGSEC-PR/2023-1, dated 29-9-2025 until further Notification.

Now, the State Election Commission, in exercise of powers conferred under Article 243-K of the Constitution of India and Sub-Section (2) of Section 14, Sub Section (2) of Section 15, Section 197 and Section 198 of Telangana Panchayat Raj Act, 2018, in modification/supersession of the Notification No. 660/TGSEC-PR/2023-1, dated 29-9-2025 and Notification No. 660/TGSEC-PR/2023-4, dated 9-10-2025, hereby calls upon the registered voters of the following categories of Gram Panchayats Notified in Schedule-VIII of the Telangana Panchayat Raj Act, 2018 i.e.

1. Gram Panchayats whose term of office has already been expired (Except (25) Gram Panchayats of Mangapet Mandal in Mulugu District, (2) Gram Panchayats of V.Saidapur Mandal in Karimnagar District and (4) Gram Panchayats of Enkoor Mandal & (1) Gram Panchayat of Penuballi Mandal in Khammam District due to orders of the Hon'ble Courts) and whose Ordinary Elections could not be conducted earlier due to any reasons; and

2. The newly created Gram Panchayats therein,

to elect Members and Sarpanchas of their respective Gram Panchayats and also notifies the Schedule for conduct of the said elections in Annexure-I appended to this Notification.

Revenue Division wise Mandals, Gram Panchayats and Number of Wards going for poll in each District in Three Phases are indicated respectively in Annexure - II appended to this Notification.
