In the memo 1st cited, orders were issued to pay wages to outsourced personnel working in CBD Gang as per Artisan Grade-I instead of Artisan Grade-II, Grade-III & Grade-IV irrespective of their categorization. In the memo 2nd cited, it was ordered that AGI shall be released as per the actual grades only and the difference in the basic pay shall only be allowed and shall be shown as Special Pay to the Artisans working in CBD, SMG etc., as long as they work in that wing.

- 2. In the T.O.O. 3rd cited, TGTRANSCO Revised the Pay Scales and Allowances to the Artisans with effect from 01.04.2022. In the memo 4th cited, orders were issued for payment of special allowance @ 10% on MOGS to the Artisans grades II, III & IV working in CBD, SMG, MRT etc., without allowing the DA and HRA on Special Allowance.
- 3. In the references 5-10 cited, proposals/representations were received from the field offices and from the Artisans working in CBD gangs, requesting for sanction of special allowance or increase in wages. Further, the Trade Unions are also requesting for the same.
- 4. After careful examination, TGTRANSCO hereby directs the Chief Engineer/ Zones and all Pay Drawing Officers of TGTRANSCO to pay Special CBD Allowance to the Artisans of Grades II, III & IV working in CBD gangs w.e.f. 01.08.2025, duly discontinuing the existing Special Allowance @ 10% on MOGS, as follows: -

SI.No.	Artisan Grade	Special CBD Allowance
).	(in Lumpsum per month)
1.	Grade-II	Rs.6,000/-
2.	Grade-III	Rs.8,000/-
3.	Grade-IV	Rs.10,000/-

- a) Special CBD Allowance shall be allowed only to the Artisans working in CBD Gangs.
- b) The Special CBD Allowance shall not be allowed for the leave period and it shall be allowed only for the duty period.
- c) The Special CBD Allowance shall not be paid to the Artisans who are transferred out from CBD Gang or his services are not utilized in CBD Gang.
- d) No DA and HRA shall be allowed on Special CBD Allowance.

- 5. The Special Allowance @ 10% on MOGS ordered in Memo 4th cited shall be continued to the Artisans working in other areas.
- 6. The Chief Engineer/IT/TGTRANSCO is directed to make necessary changes in SAP.
- 7. These orders are issued with the concurrence of the Director (Finance) vide Regd.No.355, dt.28.07.2025.
