In the T.O.O 3<sup>rd</sup> cited, TGTRANSCO adopted the orders issued by the Government of Telangana in G.O.Ms.No.58, Finance (HRM.IV) Department, dt.22.06.2023, wherein the Government enhanced the conveyance allowance at 10% of Basic Pay subject to a maximum of Rs.3,000/- per month to the Blind, Hearing Impaired and Physically Handicapped employees.

2. Certain Artisans have requested for enhancement of the PH conveyance allowance in accordance with T.O.O 3<sup>rd</sup> cited to the Blind, Hearing Impaired and Physically Handicapped Artisans of TGTRANSCO, on par with Employees.
3. After careful examination, the HODs of TGTRANSCO are instructed that the Blind and Physically handicapped Artisans working in TGTRANSCO are eligible for sanction of Conveyance Allowance to Blind and Physically handicapped employee, as enhanced in T.O.O.Ms.No.2165 dt.28.12.2024 i.e., from the date of exercising their option.
4. These orders are issued with the concurrence of JMD(Fin.,Comml.,& HRD) vide Regd.No.1379, dt.21.04.2025.
