In the reference 1<sup>st</sup> cited, Government of Telangana has issued orders prohibiting Strike in all services under the Transmission Corporation of Telangana Limited and two Distribution Companies (i.e.TGNPDCL & TGSPDCL) for a further period of six months with effect from 25.02.2025 in exercise of the powers conferred by Sub-sections (1) & (3) of section 3 of the Telangana Essential Services Maintenance Act, 1971 (Act 20 of 1971). TGTRANSCO has communicated the above Government Order to all Offices of TGTRANSCO vide Endt.No.17/2014, dated 07.05.2025.

2. Telangana State Power Employees Joint Action Committee (TSPEJAC) have informed that observe work Boycott and hold demonstration on 09<sup>th</sup> July, 2025 at Corporate/Circle/Division Office excluding Employees & Artisans working in shift duties in T.G.Power Utilities as per call given for Nation Wide Strike given by National Coordination Committee of Electricity Employees & Engineers (NCCOEEE) in the Electricity Sector.

3. After careful examination, instructions are hereby issued to all the HOD's/ Functional Heads of TGTRANSCO to inform all the Employees & Artisans working under their control not to participate in the above general strike on 09<sup>th</sup> July 2025.

4. Therefore, all the HOD's/Functional Heads of TGTRANSCO are requested to take necessary action accordingly.
