ORDER:

In T.O.Os 1st to 3rd cited, orders were issued by the united APTRANSCO for implementation of the provisions of the EPF & MP Act, 1952 and the Employees' Provident Funds Scheme, 1952 to the Employees of united APTRANSCO who were appointed/absorbed and joined on or after 01.02.1999.

- In T.O.O. 4th cited, orders were issued for implementation of the provisions of Payment of Gratuity Act 1972 read with Payment of Gratuity (Central) Rules 1972 and the AP Payment of Gratuity Rules 1972 to the Employees who were appointed/ absorbed and joined on or after 01.02.1999 in the service of united APTRANSCO and accordingly paid gratuity under the provisions of the said Act/Rules in vogue from time to time.
- Consequent to bifurcation of Andhra Pradesh State into Telangana State and Andhra Pradesh State (as per A.P.Re-organisation Act, 2014), the Transmission Corporation of Telangana Limited (TGTRANSCO) was formed for the State of Telangana w.e.f. 02.06.2014. Accordingly, vide Office Order 5th cited, TGTRANSCO adopted all the Acts, Rules, Regulations, Orders etc., that exists as on 01.06.2014 for TGTRANSCO mutatis mutandis w.e.f. 02.06.2014 until further orders.
- In exercise of the powers conferred by sub-section (3) of Section-4 of the Payment of Gratuity Act, 1972 (39 of 1972) in Statutory Order No.1420 (E), the Central Government vide its Gazette Notification No.1283 dt.29.03.2018 specified that the amount of gratuity payable to an employee under the said Act shall not exceed Twenty Lakh rupees. Further in exercise of the powers conferred by sub-section (2) of Section-1 of the Payment of Gratuity (Amendment) Act, 2018 (12 of 2018) in Statutory Order No.1419 (E), the Central Government appoints the 29th day of March, 2018 as the date on which the said Act shall come into force.
- The Trade Unions representing the Employees in TGTRANSCO have requested the management of TGTRANSCO seeking payment of gratuity as per the Payment of Gratuity Act, 1972 for the Employees who were appointed/absorbed and joined on or after 01.02.1999.

- The Transmission Corporation of Telangana Limited, after careful consideration hereby orders that the amount of gratuity payable to the Employees who are appointed/absorbed and joined on or after 01.02.1999 shall be under the provisions contained in the Payment of Gratuity Act, 1972 read with Payment of Gratuity (Amendment) Act, 2018 (12 of 2018) as stated in T.O.O. 4th cited, and shall not exceed Twenty Lakh rupees.
- 7. These orders shall come into force with effect from 29th March, 2018.
- These orders are issued with concurrence of Director (Finance, Comml., & HRD) vide Regd.No.1987, dated 20.11.2025.
