ORDER:

In the reference 4th cited, the Director, Yashoda Healthcare Services Limited, Malakpet, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.22,35,536/- (Rupees Twenty two lakhs fifty five thousand five hundred and thirty six only) towards the medical treatment extended to Sri P.Devanna, Artisan Gr-IV, ID.No.1180 O/o.SE/OMC/ Adilabad as in-patient from 09.06.2025 to 14.07.2025 for “Departmental Accident Electrocution Burns (63% BSA) with 2-3 Degree Burns MM” at Yashoda Healthcare Services Limited, Malakpet, Hyderabad and requested for payment in favour of Yashoda Healthcare Services Limited.

After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TG Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 and read with memo dt:22.10.2020, the Chairman & Managing Director hereby accords sanction for an amount of Rs.21,24,095/- (Rupees Twenty one lakhs twenty four thousand and ninety five only) for reimbursement of medical charges to Yashoda Healthcare Services Limited, Malakpet, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.1,11,441/- (Rupees One lakh eleven thousand four hundred and forty one only) towards the excess amount claimed by Yashoda Healthcare Services Limited, Malakpet, Hyderabad.

The Pay Officer/TG Transco/VS/Hyderabad is requested to arrange for payment of Rs.21,24,095/- (Rupees Twenty one lakhs twenty four thousand and ninety five only) (from Special Sanction Ceiling) to Yashoda Healthcare Services Limited against their credit bill under intimation to the Chief General Manager (HRD)/TG Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.21,24,095/- is sanctioned to Sri P.Devanna, Artisan Gr-IV, ID.No.1180 O/o.SE/OMC/ Adilabad.

5. The expenditure of Rs.21,24,095/- shall be accounted for under Special Sanction G.L. A/c.No.750614 – Artisans.
