ORDER:

Of late, the services of Sri N.Sreedhar Reddy, Advocate and Standing Counsel for TGTRANSCO before Hon'ble High Court for the State of Telangana are being utilised for representing and defending TGTRANSCO and TGPCC/TGDISCOMs in the petitions filed before Telangana Electricity Regulatory Commission (TGERC).

2. TGTRANSCO/TGPCC after careful consideration hereby accords approval for payment of professional fee/Remuneration of Rs.50,000/- (Rupees Fifty Thousand only) per a day of hearing, subject to maximum of Rs.1,50,000/- per month (irrespective of number of cases per month) to Sri N.Sreedhar Reddy, Standing Counsel for representing and defending TGTRANSCO and TGPCC/TGDISCOMs in the petitions filed before TGERC.

3. The payment of professional fee to the Standing Counsel shall be made on monthly basis by TGTRANSCO. The professional fee to Standing Counsel and applicable taxes (if any), shall be equally shared by TGTRANSCO & TGDISCOMS/TGPCC.

4. The Chief General Managers / Finance / TGDISCOMs (TGSPDCL & TGNPDCL) are requested to arrange for reimbursement of their share of monthly fee along with applicable taxes (if any) in the form of Demand Draft in favour of "Pay Officer, TGTRANSCO, Vidyut Soudha, Hyderabad" payable at Hyderabad.

5. The FA&CCA (Accounts), TGTRANSCO, Vidyut Soudha, Hyderabad is also requested to ensure that the reimbursement of the share of monthly payments to the said Advocate for appearance before TGERC is received from the respective TSDISCOMs.

6. TGTRANSCO/TGPCC reserves its right to terminate the services of Sri N.Sreedhar Reddy as Standing Counsel to TGTRANSCO/TGPCC before TGERC, at any time without prior notice.
