### ORDER:

In the para-3 of the TOO 4<sup>th</sup> cited, the united APTRANSCO issued Amendment-II to the existing proviso under Column-3 against Column-2 for direct recruitment to the post of Sub-Engineer (Electrical, Mechanical, Civil & Telecom) under Column-1 mentioned in Annexure-III as follows:

*“Must have a Diploma in Engineering in relevant discipline i.e., Electrical / Mechanical/ Civil/ Telecom or Graduation in Engineering in relevant discipline **in addition to Diploma in relevant discipline** or any other equivalent qualification recognised by the Board/ Government of AP/ India /UGC/DEC/AICTE as the case may be”.*

2. Consequent to bifurcation of united Andhra Pradesh State into Andhra Pradesh & Telangana State, TGTRANSCO is formed for the State of Telangana. Accordingly, in Office Order 6<sup>th</sup> cited, TRANSCO ordered that the Acts, Rules, Regulations, Manuals, Specifications, Guidelines, Orders, Service Regulations, Conduct Rules etc., that exists as on 01.06.2014 in APTRANSCO be adopted for TSTRANSCO *mutatis mutandis* with effect from 02/06/2014 until further orders.

3. During the discussions held on 05.07.2025 between the officials of the TG Power Utilities and Senior Advocate for common direct recruitment in TG Power Utilities, the Senior Advocate opined that the words “Graduation in Engineering in relevant discipline in addition to diploma in the relevant discipline” occurring at Amendment-II under para-3 of T.O.O. 4<sup>th</sup> cited are not properly framed and it requires modification.

4. After careful consideration and in partial modification to the orders issued in T.O.O. 4<sup>th</sup> cited, TGTRANSCO hereby substitutes the words occurring at Amendment-II under para-3 of T.O.O.4<sup>th</sup> cited and issues the following amendment to APSEB Service Regulations Part-III as adopted by TGTRANSCO:

AMENDMENT-II

The existing provision under column-3 against column-2 - By Direct Recruitment against the post of Sub-Engineer (Electrical / Mechanical / Civil / Telecom) under Column-1 mentioned in Annexure-III of said regulations shall be amended as follows:
