**ORDER:**

In B.P. (P&G.Per) Ms.No.229 dt.14.08.1991 at Item II (2), it was ordered that the Officers of the Rank of Chief Engineers, Superintending Engineers, FA & CCA and Dy.CCA will continue to be eligible to travel by Air subject to the approval of their tour programme by the competent authority.

2. Erstwhile APSEB at para No.10 in B.P. (P&G-Per) Ms.No.69 dt.07.07.1995, ordered that the Officers of the rank of Executive Director, Chief Engineer, FA & CCA and above shall be eligible to travel by Air on official tours.

3. After unbundling of erstwhile APSEB, the united APTRANSCO has delegated certain powers hitherto exercised by TRANSCO to newly formed DISCOMs/MD of DISCOMs in T.O.O. (GM(IR)-Per) Ms.No.86 dt.14.07.2000. In the said T.O.O, it was indicated against Item No.24 (Travelling Allowance Bills (Air Travel approval)), it was mentioned that the Chairman & Managing Directors of DISCOMs have full power to sanction.

4. Consequent to formation of Telangana State as per AP Re-Organization Act, 2014, TGTRANSCO in Office Order dt.12.06.2014 ordered that the Acts, Rules, Regulations, Orders etc., that exist as on 01.06.2014 in APTRANSCO be adopted for TGTRANSCO mutatis mutandis w.e.f. 02.06.2014 until further orders.

5. In G.O. Ms.No.71 Finance (HRM.IV) Department dt.04.05.2017, Government of Telangana as per the Recommendations of the Tenth Pay Revision Commission revised the scales of pay for travel by Air in Revised Pay Scales, 2015 to the employees of State Government.

6. In G.O.Ms.No.52 Finance (HRM.IV) Department dt.22.06.2023, the Government of Telangana has issued orders on eligibility criteria for Air Travel upon the revision of Pay Scales to the Government employees i.e., as per revised pay scales, 2020.

7. After careful examination and in line with the entitlements prescribed in GO Ms.No.52 Finance (HRM.IV) Department, Government of Telangana, dt.22.06.2023 read with T.O.O. (Jt.Secy-Per) Ms.No.1637 dt.28.04.2023, TGTRANSCO hereby notifies the eligibility criteria for Air Travel, as follows:

- a) All Officers drawing pay in the scale of Rs.112320 – 191245 (Chief Engineers and equivalent) and above in the revised pay scales of 2022 shall be eligible to perform journey by Air on official duty.
- b) Concerned Directors may permit all officers drawing Pay in the scale of Rs.96040 – 179615 (Superintending Engineer and equivalent) in the Revised Pay Scales, 2022 shall be eligible to perform journey by Air on official duty, to any place outside the State, keeping in view of the exigencies of work.

- c) All Directors jointly may permit all officers drawing pay in the scale of Rs.88440 – 167985 (Divisional Engineers and equivalent) in the Revised Pay Scales of 2022 shall be eligible to perform journey by Air on official duty outside the State, if exigencies of work warrant such a relaxation.
- d) Chairman & Managing Director may permit any employee / officer other than specified above to travel by Air on official work to any place outside the State, keeping in view the exigencies of work.
- e) All officers who are eligible for travel by Air shall travel by economy class only.

5. These orders shall come into force with immediate effect.
