ORDER :

According to APSEB Service Regulation Part III as adopted by TGTRANSCO read with the provision contained under Regulation 6 (b), the post of Junior Personnel Officer shall be filled in by Direct Recruitment @ 25% (i.e., 2nd & 3rd of every eight successive vacancies).

2. In the reference 8th cited, the Board of TGTRANSCO has accorded approval to reserve 20% of the vacant posts of JAOs and JPOs for in-service employees and to fill up the remaining 80% vacant posts through direct recruitment, on one time-basis, as was done earlier in the year 2018.

3. Accordingly, TGTRANSCO, in exercise of powers conferred in Regulation 41 of APSEB Service Regulation Part-II and Rule-7 (7) of the A.P. Electricity Reforms (Transfer Scheme) Rules, 1999 as adopted by TGTRANSCO, hereby directs that the 80% of Junior Personnel Officer (P&G Services) vacancies available as on the date of issuance of these orders be filled up through direct recruitment, duly relaxing the Regulation 6 (b) in Part-III of APSEB Service Regulations, as adopted by TGTRANSCO, as a special case, on one time basis.

4. The above relaxation is only **on one-time basis** and this shall not be a precedent in future.
