Augmentation of 220/33KV PTRs' capacities at 220/33KV SS Singotam and 220/132KV PTRs' capacity at 220/132/33KV GIS Osmania University – Administrative Approval - Regarding.

## T.O.O. CE (Transmission) Ms. No.2488

### ORDER:

- 1) The feasibility studies are conducted as per the CEA planning criteria 2023, to meet (N-1) contingency of PTRs for the expected demand of 5000MW during 2025-26 and 5800MW during 2026-27 in GHMC area to ensure alternate source connectivity at same voltage level.
- 2) The feasibility studies are also conducted considering the State Maximum demand of 19529MW during 2026-27 (Based on 20<sup>th</sup> Electric Power Survey) with GHMC demand of about 5800MW and non-GHMC load of about 13800MW to meet (N-1) contingency.
- 3) Based on the above studies, after careful examination, TGTRANSCO accords approval for the Augmentation scheme at a cost of Rs.3674.09 Lakhs in the EHT Substations mentioned below.

- 4) It is hereby authorized as follows:
  - i) The Chief Engineers/Metro zone & Rural zone shall take up the works by calling tenders and shall award the works by obtaining necessary approvals as per the delegation of powers in vogue.
  - ii) FA&CCA(Accounts) & CFO shall allocate budget of **Rs.3674.09 Lakhs** from internal resources or shall tie up loan from PFC/REC/Banks (or) any other Financial Agency for the above works.

- iii) Scheme code shall be provided and capital budget shall be allocated during 2025-26 for the subject work scheme.
- iv) The Chief Engineer/P&MM shall procure PTRs & associated equipment / material required for taking up augmentation works.
