ORDER

Load flow studies were carried out by Power Systems wing, for 2028-29 time frame regarding requirement for augmentation of ICT capacity at 400/220/132/33kV Raidurg GIS Substation in Telangana State considering Peak demand of 22488 MW (as per 20th Electric Power Survey report (EPS)) for Telangana State and observed that the augmentation of ICT capacity from 2x500 MVA to 3x500 MVA at 400/220/132/33kV Raidurg GIS Substation is required.

- 2) The proposal for augmentation of ICT capacity from 2x500 MVA to 3x500 MVA at 400/220/132/33kV Raidurg GIS Substation was approved by the CEA vide letter dated 07.10.2024.
- 3) The peak load on Raidurg GIS Substation so far reached is 650 MW on 04.05.2024. Further to Augmentation of 500MVA, 400/220kV ICT-3 at Raidurg GIS Substation, future ICT-4 bay and 400kV & 220kV Bus extensions along with associated equipment are considered to avoid difficulty in execution involving major bus shutdowns in future.
- 4) Accordingly, after careful examination, TGTRANSCO accords Administrative Approval for the Augmentation of 400/220kV ICT capacity at Raidurg GIS from 2x500 MVA to 3x500 MVA along with Bus extensions of Bus-I & II, duly considering the future requirement of future ICT-4 and associated Bays equipment at an estimated cost of Rs.99.082 Crore and Interest During Construction (IDC) of Rs.4.954 Crore. The total cost of the Scheme including IDC is Rs.104.036 Crore.
- 5) The Chief Engineer/ 400kV, Vidyut Soudha, Hyderabad is authorized to take up the works and FA&CCA (Accounts & CFO) shall provide the necessary budget as per the scope of works.
- 6) The Scheme will be executed with financial assistance from PFC/ REC/ HUDCO/ any other Financial assistance or from Internal resources.

7) This Order is issued with the concurrence of the Director (Finance), TGTRANSCO vide Regd. No.237, dated 19.07.2025.
