- 1) Administrative approval was accorded for erection of 132/33 kV Gas Insulated Sub-Station (GIS) at Seetharambagh in Hyderabad District vide T.O.O. (CE-Transmission) Ms. No.28, Dt:27.02.2017 for an amount of Rs.6363.00 Lakhs.
- 2) The Hon'ble Commission (TGERC) accorded investment approval with Commission Reference Number - CRN TS/TST/132/33 kV, GIS, Seetharambagh / Investment Approval No 6/17--2017-18. The funding for the scheme was tied up with M/s REC Ltd, New Delhi vide term loan No. 12799.
- 3) The Superintending Engineer/Construction-I has furnished the approved note for revision of administrative approval with revised scheme cost due to increase in substation, cable & bay cost and requested for issuing revised administrative approval for erection of 132/33 kV Gas Insulated Sub-Station (GIS) at Seetharambagh.
- 4) After careful consideration, TGTRANSCO accords revised administrative approval for erection of 132/33 kV Gas Insulated Sub-Station (GIS) at Seetharambagh in Hyderabad District works out to Rs.10812.44 Lakhs and Rs.405.47 Lakhs towards Interest During Construction (I.D.C). The total cost of the scheme is Rs.11217.91 Lakhs (Rupees Eleven Thousand Two Hundred Seventeen Lakhs Ninety One Thousand Only) including IDC as per the abstract given below.
