ORDER

- 1) In accordance with the provisions of AP Re-organization Act, 2014, the erstwhile APERC granted Transmission License No. 1 of 2014 to Transmission Corporation of Telangana Limited vide proceeding No. APERC/Secy/160/2014, Dated 11.07.2014.
- 2) As per Clause (4)(2) of Regulation 2 of 2016 cited (2), the Transmission Licensee shall pay Annual License Fee for the FY2026-27 @ Rs.2000/- per MW of Allocated Contracted Capacity as per the tariff order approved by the Hon'ble Commission, before 15-04-2026.
- 3) In the order cited (4), the Hon'ble TGERC issued Transmission Tariff Order for FY:2026-27 for TGTRANSCO on 28-03-2026 with effect from 01-04-2026.
- 4) The annual license fee for FY 2026-27 payable on approved contracted capacity for FY2026-27, i.e., 22,244.39 MW works out to Rs. 4,44,88,780 /- (Rupees Four Crores Forty Four Lakhs Eighty Eight Thousand Seven Hundred And Eighty only)
- 5) Approval is hereby accorded to release an amount of Rs. 4,44,88,780 /- (Rupees Four Crores Forty Four Lakhs Eighty Eight Thousand Seven Hundred And Eighty only) towards payment of Annual License Fee of TGTRANSCO for FY2026-27 to the Hon'ble TGERC.
