After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TGTRANSCO and as per delegation of powers ordered in TOO.Ms. No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.83,697/-(Rupees Eighty Three Thousand Six Hundred and Ninety Seven only) to Yashoda Hospitals, Malakpet, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.700/- (Rupees Seven Hundred only) towards the excess amount claimed by Yashoda Hospitals, Malakpet, Hyd.
