ORDER:

The Director (Projects) has informed that, the CE/Construction/VS/Hyderabad is currently looking after Construction works related to 220kV & 132kV Lines & Sub-stations and DC works, which include scheme preparation, obtaining administrative approval, Technical sanction, ERC approval, Tender floating & award of contracts. During execution & post completion of works, various approvals, deviation proposals, material account finalization & supplemental items (if any) are being taken up at headquarters. Above volume of work is leading to significant delays and long pendency in finalization of various proposals.

In view of the network strengthening works aligned with the load growth, the Director (Projects) has proposed to bifurcate the existing Construction wing into two separate wings viz., Construction-I & Construction-II.

- 2. After careful examination, TGTRANSCO hereby accords approval for formation of an additional Construction wing under the control of Director (Projects), by re-designating the following posts:
 - i) The existing vacant post of CE/Digitalization shall be re-designated as CE/Construction-I with headquarters at VS/Hyderabad.

- ii) The existing post of CE/Construction shall be re-designated as CE/Construction-II with headquarters at VS/Hyderabad.
- 3. Consequent to the above re-designations, the works and staff shall be re-allocated between CE/Construction-I/ VS and CE/Construction-II/ VS as detailed below:

- 4. The incumbents against the posts re-designated herein shall be eligible to draw the usual scales of pay and allowances admissible as per rules in vogue.
- 5. These orders shall come into force with immediate effect.
