ORDER:

In the reference 5th cited, the Director, Care Hospital (A Unit of Quality Care India Pvt Ltd), Nampally, Hyderabad has preferred (2) Nos. credit medical bills amounting to Rs.1,37,081/- (Rupees One lakh thirty seven thousand and eighty one only) towards the medical treatment extended to Smt A.Shashikala M/o Sri A.Mahesh Babu, Artisan Gr-III, ID.No.0587 O/o.SE/OMC/ Metro-East/ Hyderabad & Self as in-patient from 09.04.2025 to 14.04.2025 for “Right Diabetic Foot” and to self 15.04.2025 to 19.04.2025 for “Acute Pancreatitis, UGI Bleed” at Care Hospital (A Unit of Quality Care India Pvt Ltd), Nampally, Hyderabad and requested for payment in favour of Quality Care India Limited.

2. After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TG.Transco as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt:22.10.2020, , the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.1,32,231/- (Rupees One lakh thirty two thousand two hundred and thirty one only) for reimbursement of medical charges to Care Hospital (A Unit of Quality Care India Pvt Ltd), Nampally, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.4850/- (Rupees Four Thousand eight hundred and fifty only) towards the excess amount claimed by Care Hospital (A Unit of Quality Care India Pvt Ltd), Nampally, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.1,32,231/- (Rupees One lakh thirty two thousand two hundred and thirty one only) to Quality Care India Limited against their credit bills under intimation to the Chief General Manager (HRD)/TG Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.1,26,454/- is sanctioned to Sri A.Mahesh Babu, Artisan Gr-III, ID.No.0587 O/o.SE/OMC/ Metro-East/ Hyderabad. A sum of Rs.5777/- is recoverable from the Artisan. The SE/OMC/Metro-East/Hyderabad is requested to recover amount from the salary in installments accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD)/TG Transco within a month from the last date of recovery from the Salary of the Artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/ Concerned Disbursing Officers.

5. The expenditure of Rs.1,26,454/- shall be accounted for under General Ceiling, G.L. A/c.No.750614 – Artisans.
