After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TG.Transco as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt:22.10.2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.1,17,566/- (Rupees One lakh seventeen thousand five hundred and sixty six only) for reimbursement of medical charges to Pratibha Super Speciality Hospital, Nizamabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.629/- (Rupees Six hundred and twenty nine only) towards the excess amount claimed by Pratibha Super Speciality Hospital, Nizamabad.

The Pay Officer/TG Transco/VS/Hyderabad is requested to arrange for payment of Rs.1,17,566/- (Rupees One lakh seventeen thousand five hundred and sixty six only) (from General Ceiling) to Pratibha Super Speciality Hospital, Nizamabad against their credit bill under intimation to the Chief General Manager (HRD)/TG Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.1,17,566/- is sanctioned to Sri B.Sridhar, Artisan Gr-III, ID.No.2954 O/o.SE/OMC/Adilabad.

5. The expenditure of Rs.1,17,566/- shall be accounted for under SFMS G.L.A/c.No.570163 – Artisans.
