ORDER:

In the reference 5th cited, the Director, Yashoda Hospitals, (Yashoda Health Care Services Pvt., Ltd.), Secunderabad has preferred (1) No. credit medical bill amounting to Rs.90,598/- (Rupees Ninety thousand five hundred and ninety eight only) towards the medical treatment extended to Sri J.Naresh, Artisan Gr-I, ID.No.4701 O/o.SE/OMC/Nizamabad as in-patient from 05.05.2025 to 08.05.2025 for “Perianal Abscess + Partial Fistulectomy + Procedures + MM” at Yashoda Hospitals, (Yashoda Health Care Services Pvt., Ltd.), Secunderabad and requested for payment in favour of M/s.Yashoda Health Care Services Pvt. Ltd.

After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TG.Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt:22.10.2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.90,597/- (Rupees Ninety thousand five hundred and ninety seven only) for reimbursement of medical charges to Yashoda Hospitals, (Yashoda Health Care Services Pvt., Ltd.), Secunderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.1/- (Rupees one only) towards the excess amount claimed by Yashoda Hospitals, (Yashoda Health Care Services Pvt., Ltd.), Secunderabad.

The Pay Officer/TG Transco/VS/Hyderabad is requested to arrange for payment of Rs.90,597/- (Rupees Ninety thousand five hundred and ninety seven only) (from General Ceiling) to M/s.Yashoda Health Care Services Pvt. Ltd against their credit bill under intimation to the Chief General Manager (HRD)/ TG Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.90,597/- is sanctioned to Sri J.Naresh, Artisan Gr-I, ID.No.4701 O/o.SE/OMC/Nizamabad.

5. The expenditure of Rs.90,597/- shall be accounted for under General Ceiling, G.L. A/c.No.750614 – Artisans.
