**ORDER :**

In the reference 1st cited, TGTRANSCO has accorded approval for sanction of an amount of Rs.1,52,920/- (Rupees One Lakh Fifty Two Thousand Nine Hundred and Twenty Only) towards payment of annual premium (including GST) to M/s. TATA AIG Insurance Company Ltd., Hyderabad for renewal of Group Personal Accident Insurance Coverage of Rs.50,00,000/- each (or) as per eligibility, whichever is less, to 43 Nos. trained and working Hotline staff working in the Hot Lines Wing of TGTRANSCO (as per the enclosed Annexure) for a further period of one year from 25.02.2026 to 24.02.2027.

2. Subsequently, M/s. TATA AIG Insurance Company Ltd., Hyderabad has declined to issue the GPA policy for the said insurance coverage.
